Sir,

In producing herewith the following accused person namely Iswar Munda (59 yrs) S/O Late Bigen Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles under proper seizure list viz :- (i) One paper made cartoon containing 12 bottles of "KINGFISHER IMPERIAL STRONG BEER" each bottle containing 650 ml i.e total (12 x 650 ml =7.8 ltrs) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1" and (ii) one multi colour nylon bag containing 04 bottles of "KINGFISHER IMPERIAL STRONG BEER" each bottle containing 650 ml i.e total (04 x 650 ml =2.6 ltrs marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1". I, SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the accused person namely Iswar Munda (59 yrs) S/O Late Bigen Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 25.04.25 at 13.45 hrs myself along with force left the PS to perform PC Mobile van duty vide Pradhan Nagar PS GDE No 1369 dated 25.04.25. During my duty at around 19.15 hrs I received source information that one Iswar Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling is selling illicit liquor illegally at his residence and he stored huge quantity of illicit liquor at his residence without any valid documents. Accordingly, I informed the matter to you over phone. As per your kind order and direction, I along with SI Goutam Mallick, ASI Prabal Sarkar along with force all of Pradhan Nagar PS left for Dimbuline, Mohur Gong under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at Dimbuline, I contacted with my source and as identified by him, I along with other officers and force entered into the residence of said Iswar Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling and conducted a raid and managed to detain him. On interrogation he disclosed his identity as noted above. On further interrogotation he disclosed that he is selling liquor at his residence without any valid documents. On search the above noted illicit liquor was recovered from his residence. On demand he failed to produce any valid documents or licence to possesssing/storing such illicit liquor at his residence. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal liqior from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 20.10 hrs to 20.30 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Iswar Munda (59 yrs) S/O Late Bigen Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Iswar Munda (59 yrs) S/O Late Bigen Munda of Dimbuline, Mohur Gong, PS- Pradhan Nagar, Dist. Darjeeling for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
