Sir,

I'm producing herewith 01 (one) accused person namely Ankaj Roy (29 yrs) S/O Dinesh Roy of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One Semi-Automatic small fire arms (Pistol) measuring approx 08 (eight) inches in length including its 04 (four) inches pistol grip, approx 08 (eight) inches barrel having ejection slot, trigger, trigger guard, firing pin, firing hammer and magazine in proper working condition - Marked as Exhibit-"A" and (ii) One (01) live ammunition marked as Exhibit "B".

I, SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused persons namely Ankaj Roy (29 yrs) S/O Dinesh Roy of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist. Darjeeling to the effect that today i.e. on 25.04.25 at 22.25 hrs. I received a reliable specific secret source input that one person is moving at near Darjeeling More area under PS- Pradhan Nagar, Dist. Darjeeling with illegal fire arms in his possession with a view to sell the same to his designed customer or to commit any heinous crime. Accordingly, I diarized the information in P.S. General Diary vide Pradhan Nagar PS GDE No. 1404 dated 25.04.2025 and informed the fact to you. As per your kind order and direction at around 22.35 hrs myself along with SI Rajiv Subba, ASI Prabal Sarkar, C/1413 Sujit Sarkar and C/473 Amrita Sarkar all of Pradhan Nagar PS left for Darjeeling More under P.S- Pradhan Nagar, Dist. Darjeeling with investigation kit to work out the information by Govt, vehicle vide Pradhan Nagar M.C.C. No. 374/25 dated 25.04.25 GDE No 1405 dated 25.04.25. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way, I share the information with my team and also share the information with RT mobile van officer ASI Amar Raj Subba and directed him to come to Darjeeling More to accompany with us. After arrival at Darjeeling More I requested two persons namely (i) Amit Nayak S/O Ashok Nayak of Ratanlal Busty, Darjeeling More, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Nayan Singha (42 yrs) S/O Nikhil Singha of Rajib Nagar, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contact with my source and as indicated by the source we noticed that one person was standing near Darjeeling More under PS- Pradhan Nagar, Dist. Darjeeling. We cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we able to apprehend him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). As per source information that he is possessing fire arms and ammunition, hence immediately, I searched him with the help of my team in presence of independent witnesses and recovered one (i) One Semi-Automatic small fire arms (Pistol) measuring approx 08 (eight) inches in length including its 04 (four) inches pistol grip, approx 08 (eight) inches barrel having ejection slot, trigger, trigger guard, firing pin, firing hammer and magazine in proper working condition loaded with one (01) live ammunition inside the magazine. On interrogation, he disclosed his identity as noted above. On demand he failed to produce any document in respect of firearm and ammunition which was found in his exclusive and conscious possession. On further interrogation he admitted that he came there to delever the said fire arms and live ammunition to one of his customer for his wrongful gain. Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, then I seized the above mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledge by the detained person. The videography executed by videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, Ward No-22, PS- Siliguri, dist. Darjeeling as per norms of BNSS and subsequently arrested him by preparing memo of arrest as he possessing and carrying illegal fire arms and ammunition and violated the provision of Arms Act. I issued a copy of memo of arrest and the written information regarding ground of his arrest to him.


From the above noted facts and seizure of incriminating articles there is strong reason to believe that the above noted accused person is desperate and dangerous in nature, as he was carrying the said illegal fire arm and ammunition with an objective to sale the same of to commit heinous crime in the locality.

As he wilfully violated the regulation of Arms Act, therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Ankaj Roy (29 yrs) S/O Dinesh Roy of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation.


