Subject: First Information Report

Respected Sir,

I, the undersigned would like to draw your kind attention towards the fact that today at around 8:30am to 8:45pm I along with my wife was near Mitra Sangha, Tilaksadhu More, Siliguri. At that time one Alope Das @ Chottu, son of unknown, resident of Niranjan Nagar, Ward No. 36 of SMC, Post Office: Ghogomali, Police Station: Bhaktinagar came to me and suddenly without any instigation assaulted me with fist and blow to which I sustained grievous injury. The Accused Person also physically assaulted my wife in the public place and outraged her modesty and tore her wearing apparels. The said accused person is very well known notorious criminal. Previously the accused person tried to capture various persons land and also vandalize various properties. In this regard a specific case has been registered being Bhaktinagar Police Station Case No. 224 of 2025 dated 08.03.2025 under section 126 (2)/ 117 (2)/ 118(2)/351 (2)/3(5) of the BNS. At about 12:00am the said accused person called me several times being mobile number: 8617619253, 7872976288 and threatened me with dire consequences.

Therefore you are requested to initiate legal action against the accused person as per provision of law and punished as per suitable provisions of law.
