Sir,

In producing herewith one arrested lady accused person namely Jyostna Roy (45) w/o- Lt. Gobinda Roy of Ektiashal KhaiKhai Bazaar, PO- Sevoke Road, PS- Bhaktinagar, Dist- Jalpaiguri along with the following articles under proper seizure list: -
[1] 30 (Thirty) sealed bottles of "KACHI" 70 UP PET India Made Liquor each bottle containing 300 ml, i.e. $300 \times 30 = 9000$ ml, having M.R.P. of Rs. 40/- i.e. $40 \times 30 = 1200/-$, blended and bottled by Prakash Distillery & Chemical Co. (P) Ltd, Bandrijote, Pradhan Nagar and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, ASI Tapan Roy s/o Lt. Phanindranath Roy of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate do hereby lodge this written complaint against the above-noted arrested accused person namely Jyostna Roy to the effect that today on 25/04/2025 at 12:50 hrs, I received a piece of source information that a person has stored the illicit liquor and is selling the same in her tin shed house at Khaikhai Bazaar under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No.744 Dated 25/04/2025, and shared the information with O/C Ashighar OP. As per his kind direction, I along with force including lady left for Khaikhai Bazaar under PS - Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of source information in hand. We reached there at about 13:25 hrs and as identified by the source we held a raid at the tin shed house of Jyostna Roy and managed to apprehend her. On being asked he disclosed his identity as noted above and stated that he has stored the illicit liquor and is selling the same at his tin shed house without any valid license for her wrongful gain. On further search, the above-noted seized articles were recovered from his tin shed house. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, she stated that she had been involved in selling and storing illicit liquor without any valid license for the last few months for her illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the person mentioned above named Jyostna Roy after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 13:30 hrs. to 13:37 hrs under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person Jyostna Roy (45) w/o- Lt. Gobinda Roy of Ektiashal KhaiKhai Bazaar, PO- Sevoke Road, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
