Sir,

I am the complainant above named, apprise your attention on the matter that I am the legally wedded wife of the accused no. 1 named herein above and our marriage was solemnized on 20th January 2020 according to Hindu rites, customs, ceremonies and rituals at Prime Murti Resort, Dhupjhora, Lataguri under Police Station - Malbazar, District - Jalpaiguri. In the said marriage according to the demand of the accused persons who are happens to be husband, mother-in-law, Bhasur and Jaa of me respectively:

- (a) Cash amounting to Rs. 14,50,000 = 00
- (b) Gold ornaments weighing 750 grams A.P
- (c) Furniture sets
- (d) Utensils
- (e) Beddings
- (f) Sarees and other valuable articles were given by my mother.

After marriage I was taken to my matrimonial house with all stridhan properties.

Soon after my marriage all the accused persons began to tease me by uttering that the articles given in my marriage are not up to the mark and the money and gold ornaments given are insufficient and if the accused no. 1 would have been given marriage elsewhere they would get



enormous dowry articles. The accused no. 2 would say that "NEHI TO BOHU MILA, NEHI TO DAHEEZ".

They began to find fault in my each and every work and find it out abused me even calling the name of my parents. It started right after that to create pressure on me by all the accused persons to bring gold ornaments weighing five vories and money amounting to ten lakhs from my parental house for the business of my husband. As the demand of money and gold ornaments could not be fulfilled, the accused no. 1 began to assault me physically, brutally and mercilessly being provoked by other accused persons. They did not stop there, they forced me to work all day long without resting, they would not even gave me sufficient food in return, nor they provided daily necessities to me and did not take me to doctor when I fell ill. I being unable to bear such inhuman torture reported all these to my mother and she arranged rupees two lakhs with great difficulty and gave it to my husband in presence of other accused persons for the sake of my happiness. But it didn't have any far-reaching consequences.

Almost in every night my husband used to come back home being drunk, and played some cassette that I have to bring money from my father's house and picked up quarrel and beat me with articles whatever available and drove me out of the room and did not allow to enter into the room throughout the night. He used to oppress me in the name of co-habitation. The accused persons all then played a trick and sent me and my husband in a rented house, but most of the days keeping me there alone, my husband would stay at his house and took meal there. With out making arrange any food for me, I had to spend many days without food in rented house. My mother then arranged for a meeting and in the meeting the accused persons admitted their guilt and assured not to inflict torture any further and took me back to their house. But after a short span they started more tortures and did not allow me to use mobile phone nor to talk to anybody else and forced me to do all house hold works without any rest. Instead they did not provide proper food. Rather they spoke out that so long the money and gold as they demanded will not be paid I have to bear such tortures. They further gave out that they will give marriage of my husband again either driving me out of the house or killing me by any way keeping no evidence.

In order to materialize their purpose on a night at about 9.45 PM the accused persons picked up quarrel with me and then confined me in a room and started beating me catching hold of my lock of hair. My husband started to press my throat in order to kill me. The other accused then gave out that by that way if death is caused there will appear strangulation mark. Then they caused me to lie down on the bed and placed pillow on my face by my husband, while the other accused caught hold me. I somehow pushed aside the accused persons and set me free, and came out of the house and then went back to my parental house.

On the facts and in the circumstances I would pray kindly take appropriate legal steps against the accused persons for getting them punished and oblige me.
