I SI Srimanta Chatterjee S/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate lodged this written complaint against the above mentioned person. I beg to report that on 25.04.25 at about 18.10 hrs received secret source information that huge number of stolen Ranger bicycles have gathered by two guys and concealed anywhere after stolen from different places in Bhaktinagar and other PS area for selling the same for his wrongful gain.

Accordingly the information was diarized vide BKN PS/SPC GDE No. 1249 Dtd. 25.04.25 and informed to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Sadhan Kumar Roy, ASI Amal Barman and C/374 Debraj Biswas, all of Bhaktinagar PS/SPC left PS to verify the veracity of information IN C/W Bhaktinagar PS GDE No-1250 dated 25.04.25. We reached at Netajinagar near Mahananda river bed and detain two suspects. On interrogation they admitted that total eleven no's of Ranger and other cycle concealed an abundant room at Limbu busty near Fouji math under Bhaktinagar PS. Myself along with force reached at the PO and as per showing and identified of alleged persons found eleven no's of different Ranger cycles and normal by cycles. On asking they disclosed their name and address as noted above and made some incoherent talks and became perplex. On

demand they failed to give any documents in respect of the by cycles. On being questioned they could not give any satisfactory account, moreover they made some contradictory statement which is reason to believe that they procured the bicycles fraudulent means or stolen from different areas of Siliguri. Hence I arrested them u/s 35 BNSS and seized the articles after preparing proper arrested them u/s 35 BNSS and seized the articles after preparing proper seizure list in presence of witness namely (1) Sri Chaandket Singh s/o Lt Dasarath Singh of Vivekanandanagar ward no-42 PS Bhaktinagar Dist Jalpaiguri and (2) Ratan Roy-s/o Naresh Roy of Dangapara, Fatapukur, PS Rajganj Dist Jalpaiguri (Seizure was made in between 19.20hrs & 20.20 hrs) after proper audio & VDO graphed.

I therefore pray that a specific case may kindly be started against accused persons namely (1) Md Irafan-20yrs s/o Md Ershad of Netajinagar, Near Maszid, ward no-42 PS Bhaktinagar Dist Jalpaiguri and (2) Sarukh Hossain - 21yrs s/o Md Faruque Hossain of Vivekanandanagar, near Maszid, ward no-42 PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
