In producing herewith following five accused persons namely (1) Sonam Sherpa-34yrs s/o Norbu Sherpa of Burul busty, near school, PS Singtham, Dist East Sikkim (2) Amar Chakroborty-40yrs s/o Suren Chakroborty of Salugara bazaar, Post office road, PS Bhaktinagar Dist Jalpaiguri (3) Bikash Thakur-37yrs s/o Rambabu Thakur of Salugara, near Salugara foot ball math, PO Salugara PS Bhaktinagar Dist Jalpaiguri (4) Sandip Dewali-36yrs s/o Puran Dewali of Durganagar, Khichuripatty, ward no-40 PS Bhaktinagar Dist Jalpaiguri and (5) Sayan Barman-27yrs s/o Mahesh Barman of bottle company, ward no-41 PS Bhaktinagar Dist Jalpaiguri with following seized articles viz:

- 1) One Iron made adjustable wrench measuring approx 7" recovered from the exclusive and conscious possession of Sonam Sherpa
- One iron made screwdriver measuring approx 13 inches recovered from the exclusive and Conscious possession of Amar Chakroborty
- 3) One iron made hammer length approx 10 inches recovered from the exclusive and conscious possession of Sandip Dewali
- 4) One iron made hammer length approx 10 inches recovered from the exclusive and conscious possession of Sayan Barman
- 5) One Torch light from the exclusive and conscious possession of Bikash Thakur
- I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above accused persons and 3/4 others to the effect that on 25.04.25 at 21.40 hrs received a specific source information that 9/10 miscreants have assembled at fauji math, Limbu Busty under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1260 dated 25.04.2025 and as per order I along with SI Srimanta Chatterjee, ASI Khagen Barman, ASI Amal Barman, ASI Arjun Prasad Dhayani with force (K-37) van with C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for fauji math Limbu Busty under Bhakti Nagar PS, to work out the information in hand vide Bhaktinagar PS GDE No-1261 dated 25.04.25..

At about 22.10 hrs we reached at fauji math Limbu Busty being indicated by the source we noticed that 09/10 persons were assembled at fauji math Limbu Busty under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we police party somehow managed to apprehended above noted 05 (five) of them with deadly weapons in their possession but 3/4 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making

Ast Sipule Kommakon 25/04/25 preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 25.04.25 in between 22.20 hrs and 22.55 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted (1) Sonam Sherpa-34yrs s/o Norbu Sherpa of Burul busty, near school, PS Singtham, Dist East Sikkim (2) Amar Chakroborty-40yrs s/o Suren Chakroborty of Salugara bazaar, Post office road, PS Bhaktinagar Dist Jalpaiguri (3) Bikash Thakur-37yrs s/o Rambabu Thakur of Salugara, near Salugara foot ball math, PO Salugara PS Bhaktinagar Dist Jalpaiguri (4) Sandip Dewali-36yrs s/o Puran Dewali of Durganagar, Khichuripatty, ward no-40 PS Bhaktinagar Dist Jalpaiguri and (5) Sayan Barman-27yrs s/o Mahesh Barman of bottle company, ward no-41 PS Bhaktinagar Dist Jalpaiguri and 3/4 others kindly arrange for its investigation
