On May 25, 2025, at approximately 9:30 PM, My Father Das brutally attacked by a gang of

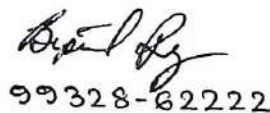
Miscreants / Gundas led by Sri Sanjay Roy at Khalbasti Nimai Jote Himul. The attackers
