Subject: Information regarding an incident/accident involving the a dump truck (Registration number WB53B4115)


Sir.

I, **Prof (Dr.) PRIYANKAR ROY**, son of Shri Pijush Kanti Roy, residing at F/N-2B, Block-5, Shantiniketan Apartment, Kalam, Sushrutanagar, Darjeeling-734012, would like to inform you that, on 16/04/2025 at about 8.30 am, I was going to my workplace at Raiganj Medical College & Hospital by my private car Mahindra XUV-500, Vehicle No- WB74AX9098. At that time, when I stopped my car near Shivmandir Traffic Guard due to the red signal, a dump truck bearing Regⁿ No. WB53B4115 coming recklessly from behind at a high speed suddenly hit my car from behind. As a result, my car was severely damaged and my mother and brother got injuries on their persons. The accident occurred due to reckless driving by the driver of the dumper truck bearing no- WB53B/4115.

I request you to kindly register this complaint, initiate an investigation, and take necessary legal action against the driver of the said dumper truck. I am also ready to co-operate fully and provide any additional details or documents required for your investigation.
