Sir,

With due respect and humble submission I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint against arrested accused person namely Saptam Roy (M/40) s/o Late Dhaneswar Roy of Bhola More, Near Yuba Sanga Club, PS NJP, Dist. Jalpaiguri after producing the following seized articles under proper seizure list.

i] Twelve (12) sealed Bottles of "60 U.P PET HIMALAYAN GOLD INDIAN MADE LIQUOR" each bottle containing 600ml [Total 12 X 600 ml = 4.800 Litres] each Bottle containing 600 ml when packed and marked as "Exhibit-A" out of which one Bottle is taken as Sample and marked as "Exhibit-A1".

ii] One piece of Yellow Color Nylon Bag printed "DHARMARAJ" on it.

to the effect that today on 25.04.2025 at about 09.15 hours I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 1052, Date: 25.04.2025 received a source information that one Saptam Roy of Bhola More is selling illicit liquor at Ambari Hat under Bhorer Alo PS. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force of Bhorer Alo PS left for Ambari Bazaar to verify the said information in hand.

At about 09.25 hours I along with force reached at Ambari hat and being shown and identified by the source I along with force held raid at Ambari Hat where Saptam Roy was selling liquor in open place. After seeing the Police team the said Saptam Roy tried to flee away but we managed to apprehend him. Further in presence of available witnesses I, along with my accompanied team searched his person and one nylon bag which was possessed by him and found/recovered the huge amount of above noted seized liquor from his possession.

During enquiry the accused person is identified as Saptam Roy (M/40) s/o Late Dhaneswar Roy of Bhola More, Near Yuba Sanga Club, PS NJP, Dist. Jalpaiguri and on further enquiry he could not produce any valid documents in respect of the above noted seized articles. On being asked he stated that he has been involved in selling and possessing of illicit liquor in open market without any valid license since few months for his illegal gain. The apprehended accused person Saptam Roy has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 25.04.2025 in between 09.45 hours to 09.50 hours.

Under the above noted fact and circumstances I, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused person namely Saptam Roy (M/40) s/o Late Dhaneswar Roy of Bhola More, Near Yuba Sanga Club, PS NJP, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
