Sub : Complaint against Mr. Nilay Gupta, son of Late Nirmal Kanti Gupta, residing at New Rangia, Tari, Post Office-New Rangia, Police Station-Matigara, District-Darjeeling for his illegal behavior and high handed action.

Sir,

I, Smt. Nabamita Gupta, wife of Sri Nilay Gupta and daughter of Sri Dilip Dasgupta, presently residing at "DASGUPTA BHAWAN", Hemanta Mukherjee Road, Deshbandhupara, Near Dadabhai Play Ground, Ward No.30 of Siliguri Municipal Corporation, Post Office-Siliguri Town, Police Station-Siliguri, District-Darjeeling, Pin-734004, West Bengal, would like to bring in your notice the following facts :-

That my marriage was solemnized with Mr. Nilay Gupta, son of Sri Nirmal Kanti Gupta on 04.02.2009 as per Hindu rites and customs and it should be mentioned here that it was arranged marriage and out of our said wedlock, two daughters were born, one is 14 years old and younger daughter is 7 years old. That my husband is a Teacher by profession.

It is to be mentioned here that after the demise of my father-in-law in the year of 2019, my husband has totally changed himself by drinking alcohol since morning 6.30 A.M. till late night in his daily routine. I found him occasional drunker since from the beginning of my marriage life, but he became addicted after the demise of his father. As a result, I and my daughters have been tortured by him specially from 2019 and situation became unbearable in the month of January, 2024 and I was forced to leave my matrimonial house on 28.01.2024. I alongwith my two daughters came to my father's house at Deshbandhupara and took the safe shelter of my father. My daughters do not want to see the face of their father due to unnatural behavior of my husband and they are always afraid of him. I and my two daughters very much mentally tortured due to the inhuman behavior of my husband. Since 28.01.2024 till today he did not provide the bread and butter to us and also not provided any tuition fees of the schools and private teachers' fees of our two daughters. My husband has sold all my stridhan, specially the gold ornaments for fulfilling his alcoholic life.

It is well known to the employer of my husband that he became the alcoholic man and as such most of the days he can not join his duty.

Since few days he asked me to go back to my matrimonial home, but as my daughters are being afraid of him and I am also in a trauma for his unnatural behavior, I did not pay any heed of his such request. He is always abusing me and my father with filthy languages over telephonic conversations. Today at about 07.30 A.M. he threatened me with dire consequences by telling if I would not go to his house alongwith my daughters then he shall kill us, thereafter, he again rang me around 09.15 A.M. asking me where am I and where is my father, I replied to him and he then directly came to my father's house. My father was in his grocery shop situated in the front ground floor of our house. Seeing him, my father told him to go to the first floor. He entered into the shop room of my father and started to abuse my father with filthy languages and beaten him on his head and hand with slippers by shouting "shuorer bachha tui amaar bou bachha der atke rekhechis, toke aj sesh kore felbo", my father had fallen down in the floor and my husband took an axe (Kural) to kill my father. One sadhu of nearby Gouriyo Math was going by the side of my father's shop, rescued my father by snatching Kural from his hand and as few more persons came to the spot, he then fled away by his scooty and at the time of his departure he shouted I will again come and kill you all.

On hearing chaos, I and my elder sister and brother-in-law came to the spot and saw my father is heavily injured due to mercilessly beaten by my husband and he was in mental trauma. We then taken him to Siliguri District Hospital and after being first-aid given by the duty doctor, we immediately went to Siliguri Police Station. Officer of Siliguri Police Station, came to the place of occurrence at about 11.00 A.M. and interrogated me, my father and said sadhu. Now, I am giving this written complaint to book the culprit immediately, as all of our family members are very much scared and getting mental agony and pain for such unnatural and unlawful action of Nilay Gupta. My father is complaining of his headache, as mostly he was beaten on head by Mr. Nilay.

Furthermore, today at about 01.20 P.M. i.e., after said dangerous incidence, said Mr. Nilay Gupta sent a threatening whatsapp text message (from his mobile no. 81457 35731) to my brother-in-law, Mr. Manotosh Dutta, wherein he said that tomorrow it will be the day of my brother-in-law and at what time my brother-in-law would send me and my daughters to the home of Mr. Nilay Gupta. I am enclosing the copy of said whatsapp text message, which is self-explanatory.

In the above circumstances, I would like to lodge this complaint before your good office to punish Nilay Gupta as per provisions of law. I also further request your benign-self to look into our safety, so that, Mr. Nilay Gupta can not come to do anything wrong with us.
