Hare Krishna Ghosh, who was hit by an unknown vehicle
on 13/04/2025.

Respected Sir,

This is to inform you that I Suku Ghosh, s/o Late Hare
Krishna Ghosh, resident of Thikni Kata, P.O. Sushruta Nagar, PS Matigara
Dist- Darjeeling beg to inform you that on 13/04/2025 my father
namely Hare Krishna Ghosh was hit by an unknown vehicle at around
08.40 pm and after near Yuvan Hospital, Kawakhata. That I came
to know about the incident at around 09.00 pm, same day by one of
my neighbour who drives a e-rickshaw. I was told by the local
persons that at around 08.40 pm when my father was coming
from medical more towards his residence, one four wheeler
vehicle (number unknown) was speeding and my father who was
riding a bicycle on the service lane got into a collision which
led to my critical injury and later death of my father. That the
person also my neighbour who stated me about the incident
carried my injured father to North Bengal Medical College & Hospital
emergency section, where my father was admitted immediately
but sadly around 05.30 am of the morning my father took his last
breath. That the vehicle fled away without stopping. That for performing the last rites
rituals of my father I could not lodge the complaint earlier.
That with great grief I am writing you this complaint
to take appropriate legal actions against the unknown 4 wheeler
vehicle and help me in this situation at the earliest.
