That yesterday I went to a makeup studio in the name and style "Sagarika Makeup Studio" situated at Dabgram, Police Station: Siliguri, Dist: Darjeeling. At around 8:30pm to 9:00pm one Sri Avijit Ghosh, Son of Sri Ashoke Ghosh, resident of C/O Ashoke Kumar Ghosh, Haldibari, Ward No. 5, Post Office and Police Station: Haldibari, Cooch Behar, Pin Code: 735122 having mobile number 97331-04086 along with 7/8 unknown persons came to me and suddenly without any instigation assaulted me with a sharp weapon due to which I have suffered grievous, sharp cuts on my wrist, neck and back. The aforementioned accused person along with the 7/8 unknown miscreants then proceeded to inflict further blows in an attempt to murder me. Subsequently, I somehow managed to escape from the studio. I then went to Siliguri District Hospital to receive treatment for my injuries. However, when I was on my way to the hospital, the aforementioned accused along with the 7/8 other unknown miscreants restrained me and also threatened me with dire consequences. Later on I came to know that the aforementioned accused person namely Sri Avijit Ghosh is currently employed in Muthoot Finance as a Manager.

Therefore you are requested to initiate legal action against the accused person as per provision of law and punished as per suitable provisions of law.
