
Sir,

I, SI Mimi Singha, of New Jalpaiguri PS do hereby lodge a case against (i) Sunil Mandol S/O Ajay Mandol, (ii) AnjuBibiW/O AktarHussain(iii) Ajay Mandol S/O DhaneshMandol (iv) Mala Devi W/O Ajay Mandol all of TV Center, Subarna Nagar Colony, PS- NJP, Jalpaiguri the effect that on 26.04.2025 I came to know from Duty Officer SI Madan Rishi that one information has been received from one Akabar Ali (Babu) Cont: 9932490834 S/O Haji SirajuddinAhmed of Jotiakali, Near central bank, Fulbarihat, PS- NJP, Jalpaiguri that one minor girl named Sonia Khatun aged 14Yrs went to Bihar with one Sunil Kumar Mandol and they got married. This is diarized at NJP PS GD vide GDE No. 1806 Dt. 26.04.2025. As per instruction of IC PS I am to enquire the matter immediately. Accordingly I left for TV Center, Subarna Nagar Colony to enquire the matter.

During my enquiry I went to TV Center, Subarna Nagar colony and found that the above minor victim aged 14 yrs was in a love relation with Sunil Mandol for the last 3 years. She went to Bihar with all the above mentioned and got married to him on 17.01.2025. It is clear that all the above mentioned persons were consciously involved in an act of child marriage. Accordingly I recovered the victim girl and inform CWC Jalpaiguri.


Hence I pray to you to kindly start a specific case against all the above mentioned accused persons under proper section of law.
