After purchasing grocery items, I was returning to my residence by foot and while I reached at Dhhop company More, suddenly two young guys came from back side by a Motor Cycle and snatched my gold chain from my neck and fled away towards Gurung Busty. I tried to catch them but in vain, but I could able to notice the motor cycle which is a new one having following temporary number viz :- WB/73/TC/057/2. The weight of of my gold chain is approx 31 (thirty one) grams.

Therefore, I request to you to recover my gold chain and take legal steps against both the culprits.
