In producing herewith the accused person namely Smt. Jitni Oraon, aged 24 yrs, w/o- Imil Oraon, resident of Kolkata Road Bhujiapani, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Eight (08) ltrs Chullu in 04 plastic bottles (each bottle of 02 ltrs) and marked as Exhibit-A. 2. Four (04) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs.

160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B. GDE 1052

3. Five (05) bottles of COSMOS FIFTY 50° UP Deluxe Whisky, each contains 750 ml @ Rs. 250/stanted BDR , out of which 01 bottle is taken out as sample and marked as Exhibit-C.

P.S Case (Total 14.150 ltrs, total value Rs. 1890/-) I, SI Binup Mahato of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written NO 129/25 complaint against the arrested accused person namely Smt. Jitni Oraon, aged 24 yrs, w/o- Imil Oraon, Dt 25.04.25 resident of Kolkata Road Bhujiapani, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on US 46 ACW 25.04.2025 at 16:10 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect Smt. Jitni Oraon at Kolkata Road Bhujiapani under PS- Bagdogra B.E. Act and the same has been selling illegally. Accordingly, the matter is diarized in GD vide Bagdogra PS endured GDE No. 1047 dated 25.04.2025 and informed the matter to O/C Bagdogra PS and as per his direction I along with C/1509 Sourav Roy Sarkar, VP/01 Anselam Kujur, CV/389 Janak Singh & LCV/210 to ASI Jayashree Roy left for Kolkata Road Bhujiapani to work out the secret source information. At around 16:35 hrs we reached at Kolkata Road Bhujiapani and being indication & identification by source we held raid at the house cum shop of the suspect and detained one female person there with the help of accompanying lady Police personnel LCV/210 Jayashree Roy and interrogated her. On interrogation, she revealed her identity as Smt. Jitni Oraon, aged 24 yrs, w/o- Imil Oraon, resident of Kolkata Road Bhujiapani, PS- Bagdogra, Dist- Darjeeling (not verified) and she introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Utpal Goswami (46), w/o- Late Ajay Goswami, resident of Gossainpur, PS- Bagdogra, Dist-Darjeeling and Upendra Basfore (43), s/o-Late Matwala Basfore, resident of Surya Nagar, Tiger Busty Officer-in-chawere present there as witness. Then, we searched the house cum shop in presence of the independent Bagdogra P.S. witnesses as well as the Police personnel. On search, the above noted liquor was recovered from the

Baggood Netropolisald house cum shop. On demand, she failed to produce any valid document/license for possessing, stocking & selling that liquor. She confessed that she had been possessing, stocking & selling liquor illegally from her house cum shop since long time for her wrongful gain. Her involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, arrested the involved accused Smt. Jitni Oraon (as noted above) with the help of accompanying lady Police personnel after observing all legal formalities and communicating her the ground of arrest as she has committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 16:35 hrs and 17:05 hrs on 25.04.2025. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Smt. Jitni Oraon, aged 24 yrs, w/o- Imil Oraon, resident of Kolkata Road Bhujiapani, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its
