In producing herewith the accused person namely Bhagban Lama, aged 52 yrs, s/o- Late Krishna Kumar Lama, resident of Mamta Nagar, Rupsingjote, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Twelve (12) bottles of Kingfisher Imperial Strong Beer, each contains 650 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-A.
 2. Four (04) bottles of EMBOSS 50° UP Fine Whisky, each contains 750 ml @ Rs. 250/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.
- (Total 10.800 ltrs, total value Rs. 2920/-)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Bhagban Lama, aged 52 yrs, s/o- Late Krishna Kumar Lama, resident of Mamta Nagar, Rupsingjote, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 25.04.2025 at 19:25 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect Bhagban Lama at Mamta Nagar, Rupsingjote under PS- Bagdogra and the same has been selling illegally. Accordingly, the matter is diarized in GD vide Bagdogra PS GDE No. 1055 dated 25.04.2025 and informed the matter to O/C Bagdogra PS and as per his direction I along with ASI Amit Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy, CV/386 Kishor Ranjan Howladar left for Mamta Nagar, Rupsingjote to work out the secret source information. At around 19:45 hrs we reached at Mamta Nagar, Rupsingjote and being indication & identification by source we held raid at the house cum shop of the suspect and detained one person there with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Bhagban Lama, aged 52 yrs, s/o- Late Krishna Kumar Lama, resident of Mamta Nagar, Rupsingjote, PS- Bagdogra, Dist- Darjeeling (not verified) and he introduced himself as the owner of that house cum shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. None of the local people agreed to be present there as witness. Then, we searched the house cum shop in presence of the Police personnel. On search, the above noted liquor was recovered from the said house cum shop. On demand, he failed to produce any valid document/license for possessing, stocking & selling that liquor. He confessed that he had been possessing, stocking & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, arrested the involved accused Bhagban Lama (as noted above) after observing all legal formalities and communicating him the ground of arrest as he has committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 19:50 hrs and 20:15 hrs on 25.04.2025. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Bhagban Lama, aged 52 yrs, s/o- Late Krishna Kumar Lama, resident of Mamta Nagar, Rupsingjote, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
