**REQUEST FOR LODGING OF FIR AND INVESTIGATION INTO THE ACCIDENTAL
DEATH OF RIFLEMAN SAMEER ALE**

1. This is to request for lodging of an FIR and initiation of an investigation into a unfortunate accident resulting in death of Rifleman Sameer Ale of this unit.
2. On 22 April 2025 at approximately 1550hours, Rifleman Sameer Ale sustained severe injuries while facilitating the parking the vehicle bearing registration Number WB 72B 7780 within the Bengdubi Military Station.
3. He was immediately evacuated to 158 Base Hospital, and after initial treatment, was referred to Neotia Getwel Multispecialty Hospital, Siliguri, for specialized care under a neurosurgeon.
4. He was diagnosed with a Traumatic Brain Injury, multiple cranial bone fractures, and Blunt Trauma to the Chest. Despite being kept under intensive medical supervision in the EICU, his condition deteriorated.
5. Unfortunately, Rifleman Sameer Ale was declared dead on 25 April 2025 at 1100hours at Neotia Getwel Multispecialty Hospital, Siliguri, while under treatment.
6. It is requested that an FIR be lodged under appropriate sections of law, a detailed investigation be undertaken into the incident, and a closure report be submitted upon completion of the inquiry.
7. Your cooperation in this matter is earnestly requested.
