Sir,

I, Sumi Mohanta, wife of Anil Mohanta, resident of Khudiram Colony, P.O. – Sevoke Road, P.S. – Bhaktinagar, District – Jalpaiguri, am lodging this FIR on the following facts:

That, on 27/04/2025, between 11:00 PM to 11:30 PM, when my son, Binay Mohanta, was resting after returning from work, our neighbor, Debesh Mohanta, son of Sushil Mohanta, who resides in the adjacent house, was partying with his friends at his residence. The loud music and noise were severely disturbing our mental peace and creating a nuisance in our home and the surrounding area at night.

Considering the situation, my son requested Debesh Mohanta to lower the volume of the sound system. However, Debesh Mohanta started abusing my son and me with filthy language and provoked my son to come out of the house to engage in a physical fight.

While my son was standing near our gate, Debesh Mohanta came out of his house armed with a sharp weapon and brutally attacked my son on his neck with the intention to kill him by beheading. As a result, my son collapsed on the ground, profusely bleeding.

Immediately thereafter, with the help of neighbors, we rescued my son and took him to Siliguri Sadar Hospital. Considering the grievous nature of his injuries, the attending doctors immediately admitted him for urgent treatment.

Therefore, I humbly request you to kindly investigate the above incident, take necessary legal action against the accused, and help me and my son in getting justice.
