Sir,

With due respect, I am producing herewith the 04 (four) arrested accused persons namely (i) Md. Sarafat of Biswas Colony, PS- Matigara, Dist- Darjeeling, (ii) Md. Imamudin @ Bearul (20), S/o- Md. Hazrat Hossain of Matigara Bazar, PS- Matigara, Dist- Darjeeling, (iii) Babul Singha (20), S/o- Lt. Nirmal Singha of Bastu Bihar, Koilur Ghat, PS- Matigara, Dist-Darjeeling and (iv) Samden Lama (29), S/o- Rupen Lama of Shirobari, PS- Kurseong, Dist- Darjeeling and the following articles under seizure :-

1. Two iron made rod measuring approximately 3 feet and 1 feet from the possession of accused named Md. Sagir.
2. One iron hammer and one wire cutter from the possession of accused named Md. Imamudin @ Bearul.
3. One hacksaw blade with frame and one torch light from the possession of accused named Samden Lama.
4. One iron made dye measuring approximately 1 feet and one torch light from the possession of accused named Babul Singha.

I, ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 28.04.2025 during night patrolling van duty at 23.40 hrs, received a secret source information that a gang of miscreants were assembled at abandoned shed at Paribahan Nagar parking area under Matigara PS, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Chandra Prakash Adhikary, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Paribahan Nagar parking, PS- Matigara, Dist- Darjeeling to work out the information in hand. At about 23.55 hrs on 29.04.2025 we arrived at an abandoned shed at Paribahan Nagar Parking under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled at under the shed and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 04 (four) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to taking preparation for committing dacoity in Matigara area. They also stated that others 06/08 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted article from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00.05 hrs to 00.26 hrs on 29.04.2025. The whole process of search & seizure was made under video graph.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons (i) Md. Sagir (21), S/o- Md. Sarafat of Biswas Colony, PS- Matigara, Dist- Darjeeling, (ii) Md. Imamudin @ Bearul (20), S/o- Md. Hazrat Hossain of Matigara Bazar, PS- Matigara, Dist- Darjeeling, (iii) Babul Singha (20), S/o- Lt. Nirmal Singha of Bastu Bihar, Koilur Ghat, PS- Matigara, Dist-Darjeeling and (iv) Samden Lama (29), S/o- Rupen Lama of Shirobari, PS- Kurseong, Dist- Darjeeling and others and arrange for its investigation.
