Sarafat of Biswas Colony, PS- Matigara, Dist- Darjeeling, (ii) Md. Imamudin @ Bearul (20), S/o- Md. Hazrat Hossain of Matigara Bazar, PS- Matigara, Dist- Darjeeling, (iii) Babul Singha (20), S/o- Lt. Nirmal Singha of Bastu Bihar, Koilur Ghat, PS- Matigara, Dist-Darjeeling and (iv) Samden Lama (29), S/o- Rupen Lama of Shirobari, PS- Kurseong, Dist- Darjeeling and the following articles under seizure:-

1. Two iron made rod measuring approximately 3 feet and 1 feet from the possession of accused named Md.

2. One iron hammer and one wire cutter from the possession of accused named Md. Imamudin @ Bearul.

3. One hacksaw blade with frame and one torch light from the possession of accused named Samden Lama. 4. One iron made dye measuring approximately 1 feet and one torch light from the possession of accused named Babul Singha.
