That my three storied building is situated at 12, Bimal Sinha Sarani, Hakimpara P.O: Siliguri, P.S: Siliguri, District: Darjeeling, West Bengal, Pin Code:-734001 and in that said building at the ground floor also have my shop under the name and style "Paul Dry Cleaners". I find it important to mention here that since the last 4 to 5 years the scustomers and delivery boys of the hotel namely "Original Dada Bhai Hotel" have been causing ruckus in that area by parking their vehicles that in front of our building and shop. On several occasions I have intimated this to Kajal Kundu who is the owner of the said hotel but no action has been taken by him in this regards even though he assured me that he will take all the necessary steps to curb the situation.

That on 28-04-2025 at around 2:00 pm when I was in my shop one of the customers of "Original Dada Bhai Hotel" namely Sri.Utpal Deb, Resident of Dabgram, Siliguri, having (Ph No:-7001690188), parked his vehicle in front of my shop but since it was business hours and my shop was open I requested him to park his vehicle at the parking of the said hotel and Utpal Deb agreed to my request and told me that he will

Park his vehicle in the parking space of the Hotel within a few minutes. Then after some time Utpal Deb on provocation of Kajal Kundu arrived at my shop and said that he will not remove the vehicle parked in front of my shop and he also physically assaulted me. My younger son namely Koustav Paul seeing my dire situation came to my rescue he requested Utpal Deb to stop assaulting me but he did not stop hitting me instead he started assaulting my son. Also my Elder Son Koushik Paul when he heard that such an incident is happening he came to our rescue and tried to amicably settle the matter but however Kajal Kundu hurled abuses at my eldest son and threatened to kill him. It is also pertinent to mention here that my youngest son namely Koustav has recently undergone a surgery and time and again requested Utpal Deb to spare him since he his physically unfit but Utpal Deb on provocation of Kajal Kundu sensitive bodily condition of my youngest son and carried on his assault. Then we some how called the police for rescuing us. The police came and told us to settle the matter amicably and we agreed to such proposal and the situation was under control and this entire incident has been recorded in the CCTV camera of the said hotel.

3. That after the said incident Kajal Kundu and his employees again came to my shop at around 6:00 pm and threatened to kill me and my family members. They also threatened that they will file false cases against me and family members and they will molest my wife and no one will be able to do anything against their act. Unable to bear the torture and fearing for the safety of me and my family's life I along with my sons went to our Ward Councillor for lodging an official complaint against these miscreants and accordingly when we arrived at the Councillor's office Kajal Kundu provoked his employees to attack us and his employees tried to assault my eldest son and this incident has been recorded in the CCTV camera of the councilor office.

Finding no other alternative and fearing for the safety of me and my family, I am lodging this F.I.R. Therefore, I am praying before you that
