

Sir,

I, Ranadip Mazumder, Son of Lt. Kalipada Mazumder, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Md. Jahangir Alam, (Ph. 9614055155/8637532262), Resident of Ashraf Nagar, Near Masjid Road, P.O. – Haiderpara, Siliguri, Dist-Jalpaiguri, P.S Bhaktinagar, West Bengal.

While on a routine inspection on the site having consumer id 412102532, meter no A1000920176069, Last Reading as on date 9518 KWH having power connection of WBSEDCL in the name of Md. Jahangir Alam (Ph- 9614055155/8637532262) in the address being Ashraf Nagar, Near Masjid Road, P.O. – Haiderpara, Siliguri, Dist-Jalpaiguri, P.S Bhaktinagar, West Bengal, Sri Bijay Lakra, D.E. (S&LP), WBSEDCL along with Sri Bhaben Roy, S.O. (S&LP), WBSEDCL and Sri Sanjay Prasad, Sr. O.E, Power House CCC, WBSEDCL and other technical staffs observed that the electricity was being used unauthorizedly by reconnecting the Deemed Disconnected domestic meter (CMS make, Sl. No. A1000920176069, property of WBSEDCL, Last Reading as on date – 9518 KWH).

They entered the premises at 11:50 hrs on 30.04.2024 after handing over Notice to the son of Md. Jahangir Alam (who refused to sign at any document and did not co-operate with the inspection team) present during inspection. The electric line was disconnected on 10.03.2023 due to outstanding dues of amount Rs 6947/- when Last Reading recorded at the meter was 8745 KWH. Now at the time of inspection it was observed that the meter is running by reconnecting the electric line and the present reading found is 9518 KWH at the time of seize which is progressive. Hence it proved that the power was being used in an unauthorized manner by reconnecting the Deemed Disconnected domestic meter. Therefore committing a crime for theft of power as per section 135 (1) (a) & 138 (1) (b) of The Electricity Act 2003 amended on 2007 of India. Accordingly the connection was disconnected and the energy meter was seized and labelled. A copy of both inspection report and Seizure list (CMS make, 1 Phase, 240 Volts, 5-30 amps, SI No A1000920176069 with Last Reading as on date - 9518 KWH, property of WBSEDCL) were handed over to the son of Md. Jahangir Alam present during inspection who refused to sign at any document and did not co-operate with the inspection team. The inspection team exited the premises on 12:20 hrs.

Thus you are requested to kindly initiate an investigation against Md. Jahangir Alam under Section 135 (1) (a) & 138 (1) (b) of the Electricity Act 2003 amended on 2007 of India.
