In producing herewith one arrested accused person name Rakesh Mistri -30yrs s/o Sir. Panchu Mistri of Kholachand Fapri, PS Bhaktinagar Dist Jalpaiguri with seized articles viz. 10 (Ten) Pieces 7.62 mm live ammunitions.

I SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police Station do hereby lodge this written complaint against the above noted accused person to the effect that on 30.04.25 around 22.20 hrs received a Secret information from my source that one person is suspiciously moving in and around Baikunthapally, pipe line near Bappa Garage area under Bhaktinagar PS with huge ammunitions vide Bhaktinagar PS GDE No-1542 dated 30.04.25. Accordingly, I informed the intelligence to me I/C Bhaktinagar PS and under his direction I proceeded to work out the information. This refers to Bhaktinagar PS GDE no-1543 dated 30.04.25. At 22.45 hours We arrived at Baikunthapally area, again contacted with my source and being indicated and identified by him, I along with my team accompanied with SI Yuel Lepcha, ASI Dipak Karmakar, Const/ 1431 Dilip Barman & C/374 Debraj Biswas, also PS night mobile Van (K-37) SI Sekher Adhiary and force all of Bhaktinagar PS surrounded one 30/32 years aged person at Baikunthapally pipe line without any delay we apprehended him and disclosed our identity as the police personnel of Bhaktinagar PS. On the way I requested two persons namely (1) Chandan Roy s/o Maheswar Roy of Paharpur, Jalpaiguri PS Kotwali, Dist Jalpaiguri and (2) Biswajit Roy s/o Kishor Roy of Dhonda Simla, PS Banarhar Dist Jalpaiguri both are working at Bappa Garage to remain present with us during the time of any search and seizure. On examination the detained person disclosed his name and identity as noted above and also disclosed the information at hand in presence of the passersby available around the spot. Without delay we held search of his person in presence of available witnesses and recovered 10 (Ten) Pieces 7.62 mm live ammunitions which was concealed in his left waist. On interrogation the accused person made incoherent statement regarding possession of the ammunitions. He stated that he procured the ammunitions from one unknown person for selling the same. On definand he failed to produce any license/documents in respect of those fire arms.

In presence of the witnesses I seized the recovered above noted ammunitions under proper seizure list duly signed by the witnesses and the accused person after preparing label after proper audio & VDO gapped. . Accordingly, I arrested the accused Rakesh Mistri -30yrs s/o Panchu Mistri of Kholachand Fapri, PS Bhaktinagar Dist Jalpaiguri for violation provisions under Arms Act. Ground of arrest also informed to the accused person and issued proper arrest memo. Seizure was made in between hrs 23.10 hrs to 23.40 hrs.

On the above circumstances, I pray that a specific case under proper section of Arms Act. may kindly be started against the accused Rakesh Mistri -30yrs s/o Panchu Mistri of Kholachand Fapri, PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
