I, SI Sanjit Das of NBMC OP under Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that on 30.04.2025 at about 23:45 hrs, received a specific information provided by a credible source that 07 (seven) persons including four women are coming towards Desun Hospital under NBMC OP area in a car bearing Regn No- WB 77 A 2526 carrying huge quantity of illegal suspected to be Brown Sugar.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information. I reduced the information in writing vide NBMC OP GDE No. 936, Dated 30.04 2025 and I intimated the information to Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police, SPC who brought the information to the superior and after obtaining necessary order at about 00:05 hrs myself, along with a team of Matigara PS, SPC consisting of PSI Avijit Banik, ASI Bikash Roy, ASI Amal Roy, C/868 Sujal Roy, C/500 Mayaram Oraon, C/340 Pranab Adhikary, LC/1398 Ratna Roy, LC/1316 Chandana Paul all of Matigara PS, SPC took departure vide C.C. No. 815/2025 dated 01.05.2025 from NBMC OP, SPC for near Desun Hospital under NBMC OP with investigation kit by a Govt, vehicle to work out the information and the same was diarized vide NBMC OP GDE No. 02, dated 01.05.2025.

At the same time I also informed the videographer namely Mithun Singha, S/O- Lt. Baldev Singha of Kawakhali, PO- Sushrutanagar, PS- Matiara, Dist- Darjeeling to be present at near Desun Hospital, NBMC OP under Matigara PS, SPC to prepare the Video of whole process of search and seizure if any. On 01.05.2025 at about 00:15 hrs, we reached near Desun Hospital at Kawakhali 100 FT Township under NBMC OP and I met with my source and he briefed me about the detail information and stated that the suspected persons would arrive anytime through this road by a vehicle bearing Regn No- WB 77. A 2526. Before that I looked up for public witnesses to the entire process of search and solzure and found two who were unwilling but later they gave their willingness to act as an independent witnesses. The particulars of the witnesses are as follows 1] Shri Tapash Barman, S/O- Samir Barman of Bidhan Pally, PO- Sushrutanagar, PS- Matigara, Dist-Darjeeling and 2] Shri Indrajit Singha, S/O- Lt. Akhil Singha of Baro Bathu, PO- Rangapani, PS- Phansidewa, Dist- Darjeeling and 1 briefed them about the information we had and requested them to stand as witness, who agreed to be stand as witness during the process of search and seizure and other process thereafter. Accordingly we ambush ourselves at near Desun Hospital at Kawakhali 100 FT Township and waiting for the said persons.

In the mean while, O/C NBMC OP under Matigara PS sent message to SDO, Siligurl to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide NBMC OP ORG No. 29/2025, Dated- 01.05.2025. But after telephonic conversation, it came to know that due to night time and short notice, there are no Executive Magistrate available to perform the duty. In the above circumstances and the gravity of the information, if any delay occurred, the accused persons may escape. Hence, as per order of superior, O/C NBMC OP in the rank of Inspector of Police, SPC left PS for the place of occurrence to supervise the search & seizure if any.

At about 01:05 hrs, my source identified one car bearing Regn No-WB 77 A 2526 approaching towards Desun Hospital. Accordingly we stood on the road. After a hot chase we managed to apprehend the car and the seven persons who were in the vehicle. At about 01:20 hrs Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police. SPC arrived at the spot as a Gazzeted Officer where I briefed him the information in a nutshell. Also introduced the witness as noted above.

We then cordoned them and I introduced myself and the raid team members as Police officers, I appraised them about the information in hand and started to examine them thoroughly. On interrogation they disclosed their name and addresses as mentioned above. On interrogation of the detained persons, they confessed that they are possessing and carrying with huge quantity of suspected to be Brown Sugar in the dickey of the car.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained the above noted detained persons that they has legal right to tender their personal search in front of an Executive Magistrate or a gazette officer and the same was given to them in writing. In reply they wanted to be searched before any police officer.

On further interrogation, the detained persons confessed in front of the Gazetted officer Shri Sajal Roy, O/C NBMC OP in the rank of Inspector of Police, SPC, that they were in conscious possession of huge quantity of Brown Sugar which was kept and concealed in the dickey of the car bearing Display No. WB 77 A 2526. Thereafter, in presence of the Gazetted officer, and the two independent witnesses we searched the detained persons and the car. During search the dickey of the car, found one dark yellow colour cotton bag containing two transparent plastic packet which were containing suspected to be brown sugar and also found seven mobile phones as noted above. The search process of the ladies accused persons were done by the lady constable maintaining the decency of them.

On interrogation, the detained persons, stated that they brought the suspected to be brown sugar from Malda to deliver to their designated customer at Siliguri. Then, I asked them to produce the valid license/documents for carrying and possessing of the huge quantity of illegal narcotics contraband articles but they failed to produce any legal papers.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated NDPS Act. Accordingly, I had seized the above noted articles under proper seizure list duly prepared by me in presence of independent witnesses and Shri Sajal Roy. O/C NBMC OP in the rank of Inspector of Police, SPC who was acted as Gazetted officer. I also took signature of the witnesses, accused persons and Gazetted officer and put my signature as seizing officer.

Thereafter, on weighting one packet containing 1927 grams and another packet containing 1925 grams (total 3.852 Kgs), the dark yellow colour cotton bag, the car bearing Regn No-WB 77 A 2526 have been properly marked and labeled. Took signature of witnesses and accused persons in the labels in presence of the witnesses and Gazette officer. Considering the gravity of the offence and due to exceptional circumstances being unable to prior permission of the magistrate of the First Class, at this odd hour of mght, I arrested the above noted 04 (four) lady accused persons in presence of lady constable along with 03 (three) made accused persons and issued arrest memo to them accordingly, duly signed by the accused persons and witness. I also informed them the ground of arrest for the possession and carrying of contraband Narcotic drugs under the NDPS Act.

The entire process of Search, seizure, Label, Seal and arrest were done in between 01:25 hrs to 03:35 hrs. The entire process of search, seizure, seal and label was done under the supervision of Shri Sajal Roy. O/C NBMC OP in the rank of Inspector of Police, SPC acted as Gazetted officer and video graphed of search and seizure conducted through the camera of Mithun Singha, S/O- Lt. Baldev Singha of Kawakhali, PO-sushrutanagar, PS- Matiara, Dist- Darjeeling in compliance to the Order of Hon'ble High Court, Kolkata
