Subject: Written Complaint

Respected Sir/Madam,

With due respect and humble submission I, Sukhi Das, wife of Pritam Munshi, Daughter of Dipu Das, resident of Samar Nagar, Kalkut, P.O. Champasarl, P.S. Pradhan Nagar, District-Darjeeling, Pin-734003, would like to submit that I was married to one Pritam Munshi, son of Sri Satindra Mohan Sharma Munshi, resident of East Baghajatin Colony, Ward No. 02 of S.M.C, Near Mukti Manch, P.O. & P.S. Pradhan Nagar, District- Darjeeling, pin- 734003, and our social marriage took place on 18/04/2020 according to Hindu rites and customs and as per the demand of my father-in-law the entire wedding ceremony took place at the residence of my husband at East Baghajatin Colony, Ward No. 02 of S.M.C, Near Mukti Manch, P.O. & P.S. Pradhan Nagar, District- Darjeeling, pin- 734003, and at the time of my marriage as per the demands of my husband and my in-laws my parents had gifted a sum of Rs. 2,00,000/-(Rupees Two lakh) only.

That after my marriage I started residing with my husband at East Baghajatin Colony, Ward No. 02 of S.M.C, Near Mukti Manch, P.O. & P.S. Pradhan Nagar, District- Darjeeling, pin-734003, and since the first day my husband used to come home in a drunken state and assault me both mentally and physically ordering me to bring in more dowry from my parents as my husband was in need of funds to start a new business, and when I refused to do the same my husband along with my mother-in-law(Shila Sharma Munshi) and my Father-in-law (Satindra Mohan Sharma Munshi) and my aunt-in-law (Krishna Majumdar) and my brother-in-law (Avijit Majumdar) started verbally assaulting me ther after my husband started physically assaulting me, my husband along with my-in -law also threatned me with dire consequences if I failed to bring in more dowry from my parents. Thereafter when I refused to contact my parents for additional dowry my husband along with my-in-laws pressurized me to search for a job during the peak Covid- 19 Lockdown and if I failed to find a suitable job they would drive me out of my matrimonial home.

That being helpless and scared of my husband and my in-laws I was forced to contact my parents and narrate the entire ordeal to them. Thereafter my parents somehow managed to collect and give me a sum of Rs. 50,000/- (Rupees Fifty Thousand) only during the Covid pandemic which was later given to my husband by me and after receiving the said money my husband stopped the usual verbal and physical assaults upon me for a few days. That in the year of 2021 I was pregnant but even during the pregnancy I was forced to do all the household chores and when I was resting my in-laws used to taunt me stating that I was of

no use and they also warned me that they needed a grand-son to carry on their legacy and if I delivered a girl child they would drive me out of my matrimonial home along with the girl child. It is also pertinent to mention here that even during my pregnancy my husband used to come home in a drunken state and physically assault me on a regular basis.

That on 26/08/2022 I delivered a baby boy who required urgent medical treatment and for this reason my husband along with my in-laws used to taunt me on a regular basis stating that I was incapable of even delivering a healthy baby and they also pressurized me to join my previous place of work at Cosmos Mall siliguri as a sales executive and being helpless and in need of money for the medical treatment of my Child I was forced to rejoin work after 4 months from the date of delivering the child. Even during this period I was compelled to go back and forth from my place of work to my matrimonial home usually 3 or 4 times a day to breast feed my four month old child and this caused me immense hardships. However even after returning home my husband used to assault me both physically and verbally and also suspect that I was having an extra marital affair at work and that he would divorce me. It is also pertinent to mention here that I used to pay my father-in-law a sum of Rs. 4,000/-(Rupees Four Thousand) only per month from my salary.

That on 23/02/2025 my husband came home in a drunken state and started physically assaulting me with fists and blows without any reason and my husband along with all my-in-laws drove me out of my matrimonial home. Thereafter finding no other alternative I was forced to return to my matrimonial home and I also narrated the entire ordeal to my parents who convinced me to contact my husband or my—in-laws for the sake of my minor child and when I contacted my husband he threatened me stating that if I wanted to take away my child I had to put my signatures in documents prepared by them to which I obliged. Thereafter I returned to my matrimonial home with my mother to take away my child and I was forced to put my signature in documents prepared by my husband without verifying the contents of the documents for the sake of my child.

That after the above stated incident my husband has been calling me on regular basis asking for divorce stating that I have put my signature in incriminating documents and if I do not oblige with his request he will implicate me and my parents in a false case. It is pertinent to mention here that since the very first day of our marriage being a traditional indian woman I have been constantly trying to mend relation with my husband and in my-in-laws, even after the above stated incident I wanted to return to my matrimonial home for the sake of the child and his future but my husband has been threatening me stating that if I dared to return to my matrimonial home he would kill me and dump my body somewhere else and finding no other alternative I was bound to lodge this written complaint.

Therefore, I request you to kindly look into this matter and further take appropriate legal action against the above named persons.
