The accused issued a cheque bearing number 829417 dated 11/03/2025 for an amount of Rs. 2,00,000 (Two Lakhs), drawn on State bank Of India and Ektiasal Branch. Upon presentation on 21/04/2025, the cheque was dishonoured with the return memo stating "Insufficient Funds". This clearly establishes that Mr. Amit Singh, with full knowledge of having no balance, intentionally issued the cheque to defraud me. We have already sent him a legal notice regarding cheque bounce and he is resorting to threat and violence for stop us from claiming our legitimate dues. We have found that he is a habitual offender running various illegal business and defrauded various bank loans too.

His conduct reveals a wilful intention to cheat, cause wrongful loss, and misuse my trust for personal unlawful gain. This act is not a civil dispute but a criminal conspiracy punishable under the following sections:

- Section 138 of the Negotiable Instruments Act (dishonour of cheque)
- Section 420 IPC Cheating and dishonestly inducing delivery of property
- Section 406 IPC Criminal breach of trust
- Section 417 IPC Punishment for cheating

I request you to register a criminal case against Mr. Amit Singh and initiate immediate investigation, arrest, and prosecution. His fraudulent actions not only caused me severe financial loss but also constitute a serious offence against public trust in financial transactions.

I have attached the dishonored cheque, bank memo, and other relevant proof. I seek justice under the law and request swift and strict action against the accused without delay.
