Jalpaiguri, the Authorized Director of Nav Durga Barter Private Limited, having its registered office at HOLDING NO 86/206, DIN BAZAR JALPAIGURI, Pin-735101 would like to lodge a complaint stating the following facts:

- 1. That the company is the owner and is in possession of land measuring more or less 400 Decimal situated at eastern bypass near railway gate recorded in R.S. Khatian No. 855 of Mouza - Dabgram, Sheet No.21, in the District of Jalpaiguri, by virtue of various deed of Conveyance and also agreement to sale was executed by land owner in favour of company and An order of injunction was also passed by the Ld. Civil Judge (Senior Division) in Title Suit No. 89/2016 and also reconfirmed as per the order of Ld. High Court, Kolkata in FMA 1384 of 2018 and CAN 1 of 2017.
- 2. That today, i.e., 28.04.2025 at around 11 am, I got information that some miscreants namely 1. Sri Biswajit Mandal, S/o Late Jotindra. Nath Mandal, resident of Dabgram-I, P. S. Siliguri, in the District of Darjeeling, 2. Sri Goutam Mandal, S/o Sri Gouranga Mandal, Resident of Dabgram-I, P.O. & P.S. Siliguri in the District of Darjeeling, 3.Sri Dina Nath Prasad, S/o Late Joysree Prasad, Resident of Hill Cart Road, P.O. & P.S. Siliguri in the District of Darjeeling, 4. Smt Purnima Mandal (Paul), W/o Sri Krishna Chandra Mandal, Resident of Bhaktinagar Sahid Colony, P.O. & P.S. Bhaktinagar in the District of Jalpaiguri, 5.Dulal Chandra shah, S/o Sudhir Kumar Shah resident of Khalpara, Siliguri, P.O. & P. S. Siliguri, in the District of Darjeeling, & 6. Krishna Chandra Mandal, S/o Madhab Chandra Mandal, Resident of Dabgram Baribhasa, P.S.
