That said Sri Gopal Chandra Saha had purchased aforesaid quantity of puffed rice (Muri) from my said firm total amounting of Rs.3,11,296/- (Rupees three lacs eleven thousand two hundred ninety six) only on and from 14/12/2023 to 16/12/2024 on credit and out of said amount said Sri Gopal Chandra Saha had paid only Rs.8,505/- (Rupees eight thousand five hundred five) only to my said firm against invoice no. 841 dated 14/12/2023 and his present dues payment amount is Rs.3,02,791/- (Rupees three lacs two thousand seven hundred ninety one) only to my said firm against said purchase.

That said Sri Gopal Chandra Saha is a old customer of my said firm and he had requested me in the month of December 2023 that he will purchase good quantity of said items i.e. puffed rice (Muri) on credit for a period of one year due to his bad financial condition and it was his commitment to me that he will clear entire outstanding amount within the month of March 2025 though it was his commitment that he will pay some part amount in the mean time to my said firm and my said firm sold said items i.e. puffed rice (Muri) to him on credit and on the basis of his assurance as well as on good faith.

That I had requested him time to time on and from January 2024 for said entire outstanding payment of Rs.3,02,791/- (Rupees three lacs two thousand seven hundred ninety one) only against said purchase of puffed rice (Muri) and said Sri Gopal Chandra Saha had assured to me that he will clear entire outstanding amount of Rs.3,02,791/- (Rupees three lacs two thousand seven hundred ninety one) only to my said firm within the month of March 2025 and he had issued a Bandhan Bank cheque amounting of Rs.26,000/- (Rupees twenty six thousand) only dated 01/01/2025 vide cheque no. 000126 to my said firm and my said firm deposited said account payee cheque in it's UCO Bank, Burdwan Road Branch, Siliguri on 17/01/2025 but said cheque returned on 18/01/2025 with reason "alternation require drawers authentication" and thereafter, I had contacted with him and again he had assured to me that he will clear entire outstanding payment within the month of March 2025 and he had requested me that not to take any legal action against said dishonour cheque as a result of which my said firm did not take any legal action against him for said bounced cheque.
