I, SI Paresh 🖾 Barman of New Jalpaiguri Police Station, Siliguri PC in producing herewith one arrested accused namely Sanjay Sarkar @ Raja (33 years), s/o-Late Shyamal Sarkar of Barivasa, ITI more, PS-NJP, dist. Jalpaiguri along with all connected papers do hereby lodged this written complaint against Sanjay Sarkar along with 45/50 approx unknown persons to the effect that today on 01/05/2025 at 16:30 hrs. in course of performing QRT Mobile Van duty vide GDE no. 39, dated-01/05/2025 at Madani Bazar area ASI Pradip Sarkar of NJP PS who was performing Picket duty along with force at Madani Bazar, Dakhin Shantinagar area informed me that a large number of unruly people around 45/50 (approx.) suddenly entered the house of one Bikram Sarkar, s/o- Prem Kumar Sarkar-of Dakhin Santinagar PS-NJP, Dist. Jalpaiguri and started to vandalize the property of his house mercilessly over the protest of death of one of their neighbor. Accordingly, I along with force arrived to the spot at 16:40 hrs. On reaching there they found a large number of unruly mob were destroying the house property of the said Vikram Sarkar of Dakhin Shantinagar. On seeing this, myself along with force and detailed police picket duty party tried to resist the unlawful people from carrying out such illegal acts and activities any more. However, they remain deaf ear to our lawful instructions and were in a destroying and smashing mood and continued the illegal act and thus disobeyed the Police order. Immediately, I inform the fact to you sir for reinforcement to face the mob in order to maintain the law and order of the situation. Thereafter, Sir you along with a huge number of Officers and Force reached at the spot in order to tackle the situation for saving private property. In spite of several attempts of Police Officers and men to stop such unlawful activities of the mob, they damaged property of the said house and restrained Police Officials as well as attacked us by pelting stones. However, police staffs could manage to protect themselves from any injuries on their person and chased them to disperse the unruly mob. Accordingly, while chasing, the unruly mob started to disperse by running here and there taking some household properties. In the course of which, I arrested the above named accused at the spot.

Under the above facts and circumstances, I pray that an order may kindly be passed for lodging an FIR against the above named person along with 45/50 approx unknown persons, some of the moments of the incident has been video graphed in the Mobile Phone of some of the officers and force who were present at the spot, and arranged for its investigation in order to punish the culprits and oblige.
