I, **DHARIMAN KHATOON**, W/O. Amzad Ali, D/O. Jahiruddin Miya, Presently Residing at Ramkrishna Colony-03, Ward No. 47, Siliguri Junction, P.O. Pradhan Nagar, P.S. Matigara, Dist. Darjeeling, do hereby would like to inform you as follows:-

1. That I am a law abiding citizen of India.
2. That one Amzad Ali, son of Sagir Ahmed, resident of South Ambedkar Colony, Ward No. 01, Siliguri Junction, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling
3. That I and my husband Amzad Ali, son of Sagir Ahmed, resident of South Ambedkar Colony, Ward No. 01, Siliguri Junction, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling; was in a love relationship and after three long years (approximate) of relationship got married on 01.01.2025 with the consent of our parents in my parental house at Ramkrishna Colony-03, Ward No. 47, Siliguri Junction, P.O. Pradhan Nagar, P.S. Matigara, Dist. Darjeeling.

4. That at the time of marriage one 'Nikah Nama' was executed between us along with the witnesses on 01.01.2025 and after that we have started our conjugal life.
5. That on 06-02-2025, we have applied for marriage registration under Section 13 of the Special Marriage Act, 1954 vide Registration Id MARREG20250000298 and one date was fixed for final registration.
6. That soon after our marriage when I came to my matrimonial home, my **father-in law namely Sagir Ahmed**, my **mother-in-law namely Issrat Begum** and my **sister-in-law namely Sakina Khatoon** asked to bring money amounting to Rs. 2,00,000=00 (Rupees Two Lacs Only) from my parents and when I denied the same as my father is daily wage labour, it is not possible for my father to arrange money amounting to Rs. 2,00,000=00 (Rupees Two Lacs Only) immediately, the above named persons along with my husband beat me mercilessly and throw me out from my matrimonial house and I came back to my parental house.
7. That subsequently I become very puzzled and started to call my husband deliberately although I call him repeatedly he did not receive my call and started to ignore me and after few days he informed me that he wants to marry again with another girl and desperately denied our marriage and also denied to go for final hearing of marriage registration.

8. That subsequently he started to come at my parental house frequently and forcefully made physical relation with me but whenever I asked to bring me at my matrimonial house he become furious and threatened me with dire consequences.
9. That there after passing so many days my father-in law told to meet with them in my matrimonial home and as per his proposal I and my mother on 26-04-2025 went to my matrimonial home but suddenly they started to insult us by using filthy languages and they shut the door on our face.
10. That after that again on 30-04-2025 at about 7:00 PM I along with my mother went to my matrimonial home for mutual settlement but they insulted us inhumanly and my father-in-law started to beat me and he touched my private body parts and disrobe my modesty in front of my husband and when I asked for help to my husband he never ever protested the same. And when my mother tried to save me, my father-in-law also touched my mother's private body parts and disrobe her modesty and torn her blouse with the help of my husband, mother-in-law and my sister-in-law.
11. That after that incident they threatened us if we lodge any complain against them, then they will kill us by the help of anti-social persons.

12. That at present I am living in a very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband, father-in-law, mother-in-law and sister-in-law for that lodging of this F.I.R.

I therefore request before your good self to kindly look into the matter and considering the above mentioned unlawful and criminal activities of my husband namely Amzad Ali, father-in-law namely Sagir Ahmed, mother-in-law namely Issrat Begum and sister-in-law namely Sakina Khatoon and kindly take necessary action against **my husband namely Amzad Ali, father-in-law namely Sagir Ahmed, mother-in-law namely Issrat Begum and sister-in-law namely Sakina Khatoon** as per your good concern and service rules and for this act of kindness I shall remain extremely grateful to you.
