Respected Sir,

I, Vikash Sharma, son of Gangadhar Sharma, resident of Milanpally, Ward No. 25, Siliguri, Pin – 734005, do hereby lodge this FIR to the following effects:-

- That on 29th April 2025, my elder brother Yogesh Sharma had gone to Geetanjali
 hotel where he had been called to meet and talk. That at approximately 11:30 P.M.,
 I received a distress call from my elder brother Yogesh Sharma, who was weeping
 and in a state of extreme panic. He informed me that he was being unlawfully
 kidnapped and threatened with dire consequences, including death including
 death, by the associates and hired goons of Dr. Abhay Agarwal, who is known to
 practice at Medica North Bengal Clinic.
- The said miscreants demanded us to bring a sum of Rs. 1,10,000/- to Hotel Geetanjali, located at Ward No. 46, Champasari, Mallaguri, Siliguri, Pin – 734003, failing which he would be kill my brother.
- Upon receiving this alarming information, I promptly arranged the said amount and rushed to the aforementioned hotel accompanied by my relatives. Before proceeding, I made an urgent call to your police station to inform you of the situation.
- 4. Upon reaching Hotel Geetanjali, we found present Mr. Rajiv, and his unknown associates/goons. We witnessed that my brother had been tied to a chair and brutally assaulted by the said miscreants, with visible injuries including blue marks on his body, fracture of his right-hand little finger, and severe head injuries consistent with being smashed against a wall and all said cruelty was done by said Mr Rajiv, Dr. Abhay Agarwal (who had already fled from the place) and their goons as was stated by my brother.

- The assailants, upon seeing our arrival, attempted to flee the scene in a hurried manner. We managed to rescue my brother from further harm and immediately took him to SILIGURI DISTRICT HOSPITAL for medical examination.
- The attending medical officers at SDH, after initial assessment, advised us to shift
 my brother to a private facility due to the grievous nature of his injuries.
 Consequently, he was admitted to Arogya Niketan Nursing Home, where he is
 currently undergoing treatment
- The medical report issued by SDH categorically mentions multiple injuries and signs of extreme physical abuse. This clearly indicates a pre-meditated criminal conspiracy involving extortion, wrongful kidnapping, grievous hurt, and attempt to murder.
- I strongly urge your office to obtain the CCTV footage of Hotel Geetanjali dated 29/04/2025, which will reveal the full sequence of events and corroborate my son's ordeal.
- In view of the above, I request you to immediately register an FIR under appropriate sections of BNSS 2023 and take necessary legal action against:
 - Dr. Abhay Agarwal (Mob: 7080011662)
 - Mr. Rajiv, owner of Hotel Geetanjali (Mob: 62902 12032)
 - Other unknown co-accused and staff involved

This is a matter of utmost urgency and concerns the safety and life of my son. I seek your kind intervention for justice and immediate legal action against the accused persons.
