Subject: Application for Filing FIR Against My Husband for Physical Assault

Respected Sir/Madam,

I Putul Sharmawife of Pujari Sharma , residing at Baghajatin Colony, Ward no-2, Road no.-4, Near - Loknath mandir, Mukta Manch Ground , Pradhan Nagar , Siliguri-03 .I am writing this application to lodge a formal complaint against my husband for physically assaulting me.

On 02/05/2025 and 9:00 am , my husband Pujari Sharma violently beat me without any justification, causing me physical injuries and mental trauma. This is not the first instance; I have been subjected to repeated physical and emotional abuse. Despite several efforts to resolve the matter peacefully, the violence has continued and worsened.

I am in fear for my safety and well-being, and I request immediate legal action to be taken against him under the relevant sections of the Indian Penal Code, particularly for domestic violence and physical assault.

I kindly request you to register this complaint as an FIR and take appropriate action at the earliest. I am willing to provide any other required information to support my case.
