I Raju Yadav s/o Lt. Anandi Yadav aged about 50 yrs
resident of Regulated market, S.N.K Gaddi, T.D-1. P.O.
P.S. Pradhan Nagar Dist: Darjeeling would like to inform
you that today at about 12.00 clock in the afternoon
i.e. 4.5.2025 when I was going to have my lunch,
One Shyam Yadav s/o Raj Kumar Yadav, Jai Kant Yadav
s/o Shibu Yadav, Pawan Sah s/o Binu Sah and Bijay
Yadav s/o Lakshewar Yadav chased me and started to
push me, pulled my collar and punched me on my
face and kicked me with fist and blow, the above-
named persons badly assaulted me and one Shyam
Yadav punched me on my face and I started to
bleed, they threatened me to leave me the gaddi
otherwise they would murder me, thereafter sustaining
injury I went to medical treatment, the medical
slip is enclosed herewith. I somehow managed to save my
life from the above-named persons.

That again at about 8 pm when my son viz.
Nitish Yadav had come to the Gaddi to meet me
there the persons namely Hira Yadav s/o Lakshewar Yadav
Pawan Yadav s/o Binu Sah, Kundan Yadav s/o Surendra
Yadav, Ravanji Yadav s/o Hira Yadav, Shauvan Saha s/o

P.-T.-O

S/o Binu Saha, Shuji Saha S/o Binu Saha and many others caught hold of my son on the way to Gaddi and started to hit him with fists and blows, they all hit my son with Nuckle-punch on his stomach with an intention to kill him, my son has sustained grievous injury on his head and stomach and tore his T-shirt while physically assaulting him, the skin from his feet has peeled-off and is undergoing immense pain, and our life is in danger.

The condition of my son as well as mine are very bad. They are very influential persons so, requesting you to kindly take actions against the above-named culprits as per accordance with law.
