Respected Sir,

I, **Amna Khatun** (7908801044), Wife of Late Md. Ilyas Khan, resident at Ashraf Nagar, Ward No. 40 of SMC, P.S. Bhaktinagar, Dit. Jalpaiguri, beg to report you the following facts:-

1. That my husband was a cancer patient and was died on 09.6.2025.
2. That since after death of my husband all my in-laws are started blaming me that due to my reason my husband has died. And since after that they are continuously torturing me and whenever I tried to convince them they physically assaulted me. All my in-laws several times mercilessly assaulted me and para people saved me and many time police of Bhakti Nagar Police also came on my information given to them.
3. That today i.e. on 28.4.2025 at about 10 a.m. when I was working at my house at that time without any reason (i) Md. Lalu @ Firdaush Khan, Son of Late Abdul Gaffar Khan, (ii) Sajo Khatun, wife of Lalu @ Firdaus khan, (iii) Rosan Begam, Wife of Md. Firoz, (iv) Mehendi Khatun, D/O. Md. Firoz, (v) Sana Khatun, D/O. Md. Firoz, started abusing me in filthy and abusing languages and when I protest they started mercilessly assaulted me and my minor Itizajahan Khan, aged about 14 years, all they above named my relatives beaten me and my minor daughter for about 10-15 minutes. Said Lalu @ Firdaus Khan, Sajo Khatun, Roshan Begam with the intention of murder started to strangulated my neck so that I may die but anyhow I manage to free myself.

4. That seeing this I started raising hue and cry and hearing my hue and cry para people gathered at my house and saved me and my minor daughter from their hands.
5. That in this scuffling I and my daughter received severe bodily injuries on our person and we are under treatment of Siliguri S.D. Hospital.

I, therefore, request you to kindly take necessary legal action against the aforesaid person for the commission of the aforesaid offences by them upon me.
