In producing herewith, the arrested Two (02) accused persons namely i) Samir Tukaram Bheke (34 yrs./M) S/O- Late Tukaram Ganbau Bheke of Manohar, PO/PS- Manohar, Dist- Pune, Maharashtra and ii) Nilesh Pandurango Borade (34) S/O- Late Pandurango Borade of Goragoan, Po/PS- Goragoan, Dist- Pune, Maharashtra (Not verified) along with the following seized articles under proper seizure list: -

Total 06(Six) numbers of plastic sack containing Total 186.200 Kg (One Hundred Eight Six Kilograms and Two Hundred Grams) Approx suspect to be Ganja along with One orange colour Truck bearing No- MH 10DT 3092 Marked as follows: -

- (i) One Plastic sack having print as PARAS pellet feed weighting approx. 37.000Kgs [Thirty-Seven Kilograms] of suspect to be Ganja marked as Exhibit-"A".
- (ii) One Plastic sack having print as PARAS pellet feed weighting approx. 24.700Kgs [Twenty-Seven Kilograms and seven hundred Grams] of suspect to be Ganja marked as Exhibit-"B".
- (iii) One Plastic sack having print as PARAS pellet feed weighting approx 34.100 Kgs [Thirty-Four Kilograms and Hundred Grams] of suspect to be Ganja marked as Exhibit-"C".
- (iv) One Plastic sack having print as PARAS pellet feed weighting approx 36.500 Kgs [Thirty-Six Kilograms and Five Hundred grams] of suspect to be Ganja marked as Exhibit-"D".
- (v) One Plastic sack having print as PARAS pellet feed weighting approx 26.100 Kgs [Twenty-Six Kilograms and One Hundred Grams] of suspect to be Ganja marked as Exhibit-"E".
- (vi) One Plastic sack having print as PARAS pellet feed weighting approx 27.800 Kgs [Twenty-Seven Kilograms and Eight Hundred grams] of suspect to be Ganja marked as Exhibit-"F".

I, SI Tanmoy Kundu of New Jalpaiguri Police station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted Two (02) arrested accused persons to the effect that today 03.05.2025 at about 16.05 hrs I received a specific source input that One truck bearing registration no- MH 10 DT 3092 coming from Assam and heading towards Mumbai side with huge quantity of Ganja for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 151 Dt. 03.05.2025 and I informed the matter to Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri Police Station and As per his kind direction myself along with other officers and force named SI Samik Paul, SI Chabilal Singha ASI Manoj Majumder, c/ 1462 Sajan Tamang, VP/08 Laxman Roy, VP 13 Jamirul Islam all of NJP PS, Siliguri Police Commissionerate being headed by me left for Ramkrishna Line Hotel Parking, PS- NJP, Dist- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 152 dated 03.05.2025 and M.C.C. 509/25 No. dated 05.03.2025. In the mean time I also informed the Videographer namely Tapan Mandal to be present at Ramkrishna Line Hotel Parking to prepare the Video of whole process of search and seizure if any. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 16.45 hrs we arrived at Ramkrishna Line Hotel Parking and on the way to the spot, I called two independent witnesses namely 1) Md jaharlal (49) s/o Md Sukru of Pradhan Para PO Fulbari PS NJP Dist Jalpaiguri ii) Raj kumar Gupta (45) s/o Lt Ajadya Prasad Gupta of Ambikanagar Road no 1 PS NJP Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and after some time being pointed by my source, we saw one 6-wheeler truck having no MH 10 DT 3092 coming from jalpaiguri side towards Fulbari. Seeing police party, they try to fled away by increasing the speed of the vehicle but somehow, we managed to intercept the said vehicle and 02 (Two) persons inside the vehicle which was matched with our information. Accordingly, we intercepted the vehicle and apprehended the 02 (Two) accused persons who disclosed their identity as noted above and also parked the said vehicle from Assian Highway 2 to Ramkrishna Line Hotel Parking.

After disclosing our identity, we detained the above noted accused persons for a strong reason to believe that they illegally possessing Ganja in their vehicle bearing No MH 10 DT 3092 which they carrying clandestine disposal. On being asked they confessed that they possessed Ganja in their possession. I then gave her option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. Then they agreed to be searched by any one of them. Further, I served them a notice in accordance

with provisions of law in this regard. I also offered the independent witnesses and the apprehended persons to search our Police Party as per provision of law but they denied searching police party. Accordingly, at 17.55 hours I informed the matter to Shri Sonam Lama, Inspector -In-Charge, NJP PS for acting as Gazetted Officer, regarding the interception of the 02 (Two) accused persons along with one vehicle bearing registration no- MH 10 DT 3092 suspected to be possessed of Ganja and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 18.20 hrs Shri Sonam Lama, Inspector -In-Charge, NJP PS, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained accused persons as Gazetted Officer.

Then In presence of Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri Police Commissionerate two independent public witnesses I along with the team searched the vehicle bearing registration no- MH 10 DT 3092 following all formalities and recovered 06 numbers plastic sack containing of suspect to be Ganja which was kept concealed in the middle of loaded bamboo mats. On demand in presence of the Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri Police Commissionerate they failed to produce any valid document in support of possessing of the Ganja they were carrying in the vehicle bearing registration no- MH 10 DT 3092. Thereafter, I weighted 06 (Six) recovered packet sack containing said to be ganja in presence of Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri Police Commissionerate and the independent witnesses with the weighing instrument and found total 186.200 Kg (One Hundred Eight Six Kilograms and Two Hundred Grams) Approx suspect to be Ganja which are as follows- (i) One Plastic sack having print as PARAS pellet feed weighting approx. 37.000Kgs [Thirty Seven Kilograms] of suspect to be Ganja marked as Exhibit-"A".(ii) One Plastic sack having print as PARAS pellet feed weighting approx. 24.700Kgs [Twenty Seven Kilograms and seven hundred Grams] of suspect to be Ganja marked as Exhibit-"B".(iii) One Plastic sack having print as PARAS pellet feed weighting approx 34.100 Kgs [Thirty Four Kilograms and Hundred Grams] of suspect to be Ganja marked as Exhibit-"C".(iv) One Plastic sack having print as PARAS pellet feed weighting approx 36.500 Kgs [Thirty Six Kilograms and Five Hundred grams] of suspect to be Ganja marked as Exhibit-"D".(v) One Plastic sack having print as PARAS pellet feed weighting approx 26.100 Kgs [Twenty Six Kilograms and One Hundred Grams] of suspect to be Ganja marked as Exhibit-"E".(vi) One Plastic sack having print as PARAS pellet feed weighting approx 27.800 Kgs [Twenty Seven Kilograms and Eight Hundred grams] of suspect to be Ganja marked as Exhibit-"F".


Accordingly I seized the above noted articles from the conscious possession of the above noted 02 (Two) accused persons at the spot at Ramkrishna Line Hotel Parking, PS- NJP, Dist- Jalpaiguri under proper seizure list in presence of Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri

Police Commissionerate as well as independent witnesses as noted above and acknowledged by the accused persons and marked as Exhibit "A", Exhibit "B", Exhibit "C", Exhibit "D", Exhibit "E", Exhibit "F". Subsequently, I labelled the seized articles in presence Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri Police Commissionerate and independent witnesses and dully acknowledge by the accused persons as noted above. The whole process of seizure was made in between 18.45 hrs. to 19.55 hrs. on 05.03.2025. On further asked they both confessed in presence of Shri Sonam Lama, Inspector -In-Charge, NJP PS Siliguri Police Commissionerate and other witnesses that they procured the Ganja clandestinely from Assam for the purpose of supply the same to their designed customers at Maharastra area as per their requirement for their personal gain by illegal means. On interrogation they also disclosed that they have been dealing in such business of selling the Ganja illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the 02 (Two) accused persons namely i) Tukaram Bheke (34 yrs./M) S/O- Late Tukaram Ganbau Bheke, PO/PS- Manohar, Dist- Pune, Maharashtra and ii) Nilesh Pandurango Borade (34) S/O- Late Pandurango Borade of Goragoan, Po/PS- Goragoan, Dist- Pune, Maharashtra (Not verified) are involved in procuring and selling of Ganja illegally and contravening the norms of NDPS Act was established, Then, I arrested the above noted accused persons after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of seizure and arrest was made in-between 18.45 hrs.-20.05 hrs.

Under the above noted facts and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the above noted arrested accused persons namely i) Samir Tukaram Bheke (34 yrs./M) S/O- Late Tukaram Ganbau Bheke of Manchar, PO/PS- Manchar, Dist- Pune, Maharashtra and ii) Nilesh Pandurango Borade (34) S/O- Late Pandurango Borade of Goragoan, Po/PS- Goragoan, Dist- Pune, Maharashtra (Not verified) and others and arrange for its investigation.
