Sub- Written Complaint against (1) Sri Suraj Mahato, son of Prosad Mahato, along with his maternal uncle, (2) Sri Swapan Mahato, son of Late Debilal Mahato, 3) Shankar Mandal, Son of Late Gopal Mandal.

Dear Sir,

This is to inform you that I, Biplob Sarkar, Son of Ramjoy Sarkar, Resident of Porajhar, Dabgram, District- Jalpaiguri, West Bengal-734015, would like to inform you that on 29.04.2025 at around 9.30 p.m. when I was at my home attending my niece's birthday, a notorious man of my locality namely, Sri Suraj Mahato along with his maternal uncle, Sri Swapan Mahato, Shankar Mandal came to my house and started calling my name and started hurling abusive and filthy languages without any rhyme or reason. When I came out and confronted them as to why they have gathered at my house and doing such acts, the aforesaid Sri Suraj Mahato along with his maternal uncle, Sri Swapan Mahato, Shankar Mandal slapped and grabbed me and took me about 30 meters away from my house. Thereafter these aforesaid people started hitting me with fists and blows and simultaneously abused me with filthy languages. While this was happening, the said Sri Suraj Mahato, called his friends along with certain other unknown antisocial elements of our locality especially the antisocial elements who used to gather at the CCN office located near my residence. After the said phone call, within a span of 5 minutes an entire gang of approximately 30 antisocial elements gathered around me and started assaulting me with fits and blows repeatedly on my face, chest and back. When I tried to escape from their clutches the aforesaid Sri Swapan Mahato with the intention to kill me gave a fatal blow on my face and chest with a heavy blunt object and due to which I sustained grievous injuries on my face and chest. It is apparent from their violent attack that their sole intention was to kill me. Upon hearing my hue and cry for help my sister Smt Tapasa Sarkar along with certain local people of my locality rushed to the spot and tried to save me from the clutches of this notorious gang however they failed to do save me. My sister rushed back to the house to call my elder brother Raju Sarkar who upon hearing the news rushed to the spot and upon witnessing the said shocking incident, he was frightened at the sight of my horrific condition and he immediately called the local people, who then immediately intimated the police and the police immediately came to the spot and enquired about the incident and advised my family to immediately take me to the nearest hospital and seeing the arrival of the police they fled away from the spot. Thereafter my family immediately took me to the nearest hospital

where I receive my treatment. I had discovered that a cash amount of Rs.10,000/- (Rupees ten thousand) only and a gold chain was missing from my person after the aforesaid assault. It is pertinent to mention here that the said Swapan Mahato and his associates forcefully snatched the said cash along with me gold chain. It is also relevant to mention here that prior leaving from the spot, the aforesaid miscreants also threatened me that if I lodge any sort of complaint against them then I and my family shall have to suffer with dire consequences.

It is also submitted, if the aforesaid gang alongwith its associated members are not stopped immediately, they may come again and assault me again and may even try to kill me and also cause harm to my family. Due to my ongoing treatment I was unable to approach your good office at an earlier occasion.

I therefore, request you to investigate the matter and take strict penal action against the aforesaid culprits namely (1) Sri Suraj Mahato, son of Prosad Mahato, along with his maternal uncle, (2) Sri Swapan Mahato, son of Late Debilal Mahato, 3) Shankar Mandal, Son of Late Gopal Mandal, all resident of Porajhar, Dabgram, District- Jalpaiguri, along with their associates for the crime committed by them under the appropriate provisions of law.
