
Sir,

I Jahangir Badsha s/o. Gani Mohammad of Badla Gach,
P.O.Fulbarihat, P.S.N.J.P., Dist. Jalpaiguri lodged a written complainant to
the effect that

1. That I purchased the land measuring 18 decomals of land which is under
Part of R.S.Plot No372/1302, L.R.Plot No.1909, recorded in R.S.
Khatian No.2746, L.R.3593, Sheet no.16, Mouza-Binnaguri, P.S.-
N.J.P.(New), Bhaktinagar (old), District Jalpaiguri by way of sale
deed no.I -1534 year 2023 and possessing of the said land peacefully
publicly without any obstruction from any corner form any point of
time and thereafter my name also recorded in L.R.Khatian Vide L.R.
Khatian no.3593 and demarcated the land with Bamboo bera for the
safety & security of the land.
2. That today at about 9 A.M some miscreants namely 1. Sabdul
Haque s/o. Debaru Md and his son 2. Ksim Ali both residing at
Kalangini , P.O.Fulbarihat, P.S.N.J.P., Dist. Jalpaiguri along with
their 10-12 associates are determined to take forcible possession of
my aforesaid land and they broken my bamboo bera when I protest
the said illegal acts then they demand Rs.15,00,000/- (Fifteen Lakh
rupees) to me and they declare that if I give their demand money then
we stopped our illegal acts , when I refuse the same they became
threat me that they further came my aforesaid land and encroch my
land and they started false case against me with the help of their
women .

Sir it is further urged that my life and property is in danger
at the hands of those ruffians, goons and land speculators and unless
your good office take strong action against those persons who demand
Rs. 15,00,000/- (Fifteen Lakh rupees) local dada giri tax by initiating
an enquiry into the matter I shall be rendered nowhere which please
note .
