Sir,

In producing herewith one arrested accused namely Biswanath Sarkar @ Bishu (M/42) S/O Bancharam Sarkar of Purbo Dhontala, near Sub-canel, PO-Fulbari, PS- New Jalpaiguri, Dist- Jalpaiguri along with seized articles Viz (1) 10 (ten) Nos of Filled Gas Cylinder of INDANE Gas, (2) 06 (six) Nos of Filled Gas Cylinder of H.P. Gas and (3) 04 (four) Nos of Empty Gas Cylinder of H.P. Gas , I SI Krishna Parja of DD SPC, Siliguri submitting complaint against the above mentioned arrested person and others to the effect that today on 05.05.2025 at 11.15 hrs received a secret source information that one Biswanath Sarkar and others have procured and stored huge quantity of Gas Cylinder illegally at his godown at Fulbari Super Market under New Jalpaiguri Police Station and selling the same to the interested persons in high price without any valid documents or license for their wrongful gain. Accordingly, I diarised the information vide DD SPC, GDE No. 32 dated 05.05.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with ASI Sushanta Dey, Const.686 Arup Saha , Const 562 Utpal Sarkar and CV-151 Manotosh Talukder all of DD SPC left DD office at 11.35 hrs vide GDE No. 34 dated 05.05.2025 to verify the veracity of the source information.

At about 12.25 hrs we reached at Fulbari Super Market and as indicated by the source, we entered into the godown of Biswanath Sarkar after disclosing our identity and found that he stored huge quantity of Gas Cylinder. On demand he could not produce any documents or licenses in support of the possession of such quantity of Gas Cylinder. Thus it is strong reasons to believe that he have procured and stored huge quantity of Gas Cylinder illegally at his godown by fraudulent means or by stolen means. On question, he confessed that he along with others have fraudulently procured the Gas Cylinders and selling the same to the interested persons in high price. Accordingly , I seized (1) 10 (ten) Nos of Filled Gas Cylinder of INDANE Gas, (2) 06 (six) Nos of Filled Gas Cylinder of H.P. Gas and (3) 04 (four) Nos of Empty Gas Cylinder of H.P. Gas under proper seizure list in presence and duly signed by the witnesses under proper videography and arrested the above mentioned




person U/S 35(1)(b) of BNSS. I also inform him the ground of arrest. The whole process of seizure was made in between 13.05 hrs and 14.15 hrs

I therefore, request you that a specific case may kindly be started against the arrested person namely Biswanath Sarkar @ Bishu (M/42) S/O Bancharam Sarkar of Purbo Dhontala, near Sub-canal, PO- Fulbari, PS- New Jalpaiguri, Dist- Jalpaiguri and others under proper section of law.
