23) 21 jute bags full with maize containing approx 30 Kg each from where 21 packets ganja were recovered, I SI Rajiv Subba S/O Basanta Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted 02 (two) arrested accused persons namely (i) Rabin Kayal (27 yrs) S/O Sudha Kayal of Yadab Nagar, PO- Dakshin Rajarampur, PS- Kulpi, Dist. South 24 Parganas and (ii) Kalyan Bhuniya (43 yrs) S/O Late Paresh Bhuniya of Nischintapur, PS Kulpi, Dist. South 24 Parganas to the effect that on 06.05.2025 at 21.40 hrs, I received a reliable specific secret source input that one truck displaying Registration number WB976989 loaded with huge quantity of illegal Ganja is coming from Cooch Behar side for its destination towards Barasat via Burdaman Road and Hill Cart Road, Siliguri for dispose the same to their design customer at Basirhat.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 296 dated 06.05.2025 and I informed to you in writing. Subsequently, being directed by you at about 21.50 hrs myself along with SI Goutam Mallik, SI Sumit Sarkar, SI Bandhan Roy, ASI Biplab Kr Das, ASI Prabal Sarkar and others force of Pradhan Nagar PS, SPC left for Hill Card Road near Gurung Busty More under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar dated 06.05.2025 and M.C.C. No. 197/25 dated 06.05.2025. I also informed one PS GDE No. 297 Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and requested him to come to Siliguri Junction Public Bus Stand under Pradhan Nagar PS, Dist.- Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer SI Debabrata Khan (K-30) and ASI Jagannath Roy (K-31) and shared the information and requested them to come to Hill Cart Road near Gurung Busty More under PS Pradhan Nagar, Dist. Darjeleing to accompany as well assist us.

At around 22.05 hrs we arrived at Hill Cart road near Gurung Busty More under PS Pradhan Nagar, Dist. Darjeeling and contacted with my source who stated that the said vehicle is coming towards Siliguri and will cross Siliguri via Burdwan road via Air view More. Then, I requested two available independent persons namely Raja Ray (26 yrs) S/O Dilip Ray of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Niranjan Sah (28 yrs) S/O Ganga Prasad Sah of Rajendra Nagar, Coolipara, Ward No-01, PS-Pradhan Nagar, Dist. Darjeeling to remain present at the spot and act as independent witness if any search and seizure would make which they agreed. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officer SI Debabrata Khan and ASI Jagannath Roy along with force came at the spot to assist us.

Then we started Naka checking at Hill Cart Raod near Gurung Busty More and at around 22, 40 hrs me managed to detain the said truck displaying Registrtion number WB/97/6989 at Hill Cart Road near Gurung Busty More and found the driver and co-driver were inside the cabin of the said truck. I requested the said truck driver to park his vehicle beside the road. Thereafter, we disclosed our identities as Police personnel last 3/4 police personnel of our team were in civil dress for our convenience) and informed them regarding the information in hand. On interrogation they disclosed their identities as (i) Rabin Kayal (27 yrs) 5/O Sudha Kayal of Yadab Nagar, PO- Dakshin Rajarampur, PS- Kulpi, Dist. South 24 Parganas and till Kalyan Esturates (43 yrs) S/O Late Paresh Bhuniya of Nischintapur, PS- Kulpi, Dist. South 24 Parganas. During further interrogation they disclosed that the vehicle is fully loaded with corn. I further informed them regarding the information in hand and also informed that the search of the vehicle is required, I accordingly issued notice in writing to them whether they wanted to be searched in presence of an Executive Magistrate or by any Cazetted officer which they agreed to be searched in presence of any of the above noted officer.

Accordingly, I informed about the matter to you over mobile phone and requested you to arrange for an Executive Magistrate or Gazetted officer for the purpose of supervise the entire search and seizure process to the mean time, I requested to one Uma Shankar Yaday S/O Kailash Yaday of Narmada Bagan, PS Pradhan Nagar, Dist. Darjeeling, Labour Sardar of Regulated Market) to arrange at least 05 labours and to send them at Hill Cart Road near Gurung Busty More as soon as possible for the purpose of unloading and re loading of gunny bags from the detained truck. At around 23.00 hrs you arrived at the spot at Hill Cart Road need Gurung Busty More under PS- Pradhan Nagar, Dist.- Darjeeling to perform the duty of a Gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to unavailability of Executive Magistrate in such late hours of night, as a Gazetted officer you are legally authorised to give order to search the detained truck.

Then, I served a notice to you to supervise the entire process of search and seizure. In the mean time Uma Shankar Yadav S/O Kailash Yadav of Narmada Bagan, PS- Pradhan Nagar, Dist. Darjeeling Walzour Sardar of Regulated Market) arrived at the spot with five labours of Regulated market. Then, following your direction on camera, I offered the independent witnesses and two detained persons to search our police team but they denied for searching Police team. Thereafter, in presence of you and independent witnesses as noted above the said vehicle was unloaded by the labours and found total 87 Jute bags filled with corn. On being search total 21 packets wrapped with brown colour cello tape containing different amount of Ganja were recovered from 21 jute bags out of 87 jute bags which were kept concealed inside corn loaded jute bags.

On demand the above mentioned detained persons namely (i) Rabin Kayal (27 yrs) S/O Sudha Kayal of Yadab Nagar, PO- Dakshin Rajarampur, PS- Kulpi, Dist. South 24 Parganas and (ii) Kalyan Bhuniya 43 yrs S/O Late Paresh Bhuniya of Nischintapur, PS- Kulpi, Dist. South 24 Parganas failed to produce any salid document/paper for possessing or selling such huge quantities of Gajna. On further grilling, they confessed their guilt and stated that they procured the said quantities of Ganja clandestinely from Akrarhat, Dist. Cooch Behar for the purpose of selling the same in high rates to their designed customers at Bashirhat for their wrong full gain and also stated that they are engaged in such type of illegal business for the last few months. for their wrongful gain within a short period of time.

Subsequently, I scaled and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused persons at the spot. The whole process of search, seizure and labelling were made under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 23,05 hrs to 01.45 hrs as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the accused persons namely (i) Rabin Kayal (27 yrs) S/O Sudha Kayal of Yadab Nagar, PO- Dakshin Rajarampur, PS- Kulpi, Dist. South 24 Parganas and (ii) Kalyan Bhuniya (43 yrs) S/O Late Paresh Bhuniya of Nischintapur, PS- Kulpi, Dist. South 24 Parganas were involved in procuring and selling Ganja illegally contravening the provisions of NDPS Act. Then, I arrested them after observing all formalities, informing them regarding the ground of their arrest and issuing a copy of Memo of Arrest and ground of arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the following two accused persons namely (i) Rabin Kayal (27 yrs) S/O Sudha Kayal of Yadab Nagar, PO- Dakshin Rajarampur, PS- Kulpi, Dist. South 24 Parganas and (ii) Kalyan Bhuniya (43 yrs) S/O Late Paresh Bhuniya of Nischintapur, PS- Kulpi, Dist. South 24 Parganas and its investigation may kindly be arranged.
