I Swarn Roy (6290821564), Son of Bishadu Roy, Address – Dambari, Dakshin Khyerbari, Baroghria, Dhupguri, Dist- Jalpaiguri. I am working as a Technician under Reliance Jio Infocom Ltd in Siliguri.

I beg to state that at above mentioned Jio Tower on 06-05-2025 at around 10:27 am, some culprits stolen 5 nos Lithium Ion Battery from Reliance Jio Tower. I received site down alarm at 12:09 pm from control room and immediately reached site, then after checking the site equipment, I found 5 nos of Lithium Ion Battery are stolen by forcefully opening the outdoor cabinet. The approximate total cost of 5 nos stolen battery is Rs. 418000/-

In view of the above incident, we therefore request your good office to kindly lodge a FIR and initiate necessary investigation for action as per the law of the land,
