Sir,

On 23-4-2025 Learned Court of the Judicial Magistrate 4th at Silihuri passed an order in my favour directing my husband Mintu Barman, son of Sri Gokul Barman, Tarigola, Balason Colony (Beside Netaji Juba Langha) PO- New Raoria, PS- Matigara, Dist- Durgaching to give me monthly allowance of Rupees Three Thousand (Rs-3000/-) Per month towards my maintenance. Mintu Barman was present in Court while the order was passed. On the same night at about 10.30 PM, said Mintu Barman came at my present residence at Simultah Baka Lokenath Colony, PS- Matigara with some family members and friends and barged in my home breaking the main door, then they abused me in filthy language and assaulted me, brutally. They pushed me down at ground and beat me. He told me "you want maintenance from me? Now take this" and assaulted me.

Under the circumstances, I request you to investigate the case yourself or direct an investigation to be made by any Police officer initiate a case under appropriate Provisions of Law and arrest the culprit named above and do Justice to me.
