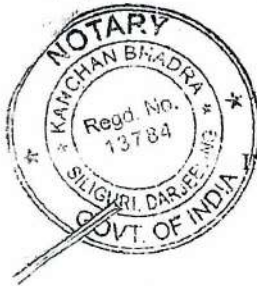

And the accused person taking undue advantage of his power, has been harassing the complainant in numerous ways, especially by abusing him with filthy languages and derogating him publicly since last 2 months.

4. That thereafter, on 10th Feb, 2025 during the counselling session of electives, the said Accused person once again abused and harassed the complainant within the premises academic block of North Bengal Medical College.

5. That later that night, the said accused person came to the room of the complainant and pretended to apologize by using sweet pleasant words and thereafter, invited the complainant to his room.
6. That the complainant being totally unaware of his malic intentions, had been to the room of the accused person. Thereafter, the accused person taking undue advantage of the situation had locked the complainant in his room and thereafter, assaulted him fists and blows. That apart, the said accused person had also assaulted him with a wooden block resulting to serious injuries.
It is pertinent to be mentioned herein that during the said assault, the aforesaid accused person had torn the shirt of the complainant and even snatched away his *Rudraksha Mala* made of silver. However, the complainant somehow saved his life and fled away from the spot. The complainant also added that the aforesaid accused person has threatened him with dire consequences.
7. That after the aforesaid incident, a written complaint was submitted to the Dean of North Bengal Medical College.
8. That thereafter, on 12/02/2025 the Complainant went to North Bengal Medical College Out Post under Matigara PS to lodge a written complaint to the Officer-In-Charge but the police personnel of North Bengal Medical College Out Post vehemently refused to accept the same and again on 15/02/2025 the Complainant went to the North Bengal Medical College Out Post under Matigara PS to lodge a written complaint but again the Complainant Complaint was refused and thereafter, subsequently on various occasions the same was refused, the complainant had even been to Matigara Police Station but the police personnel categorically refused him with an assurance to look into the matter shortly.
9. That thereafter, the Complainant had sent a written complaint addressed to the Inspector-In-Charge, Matigara Police Station, via speed post on 04/03/25 having consignment no. RW203694837IN, regarding the concerned issue, the Matigara Police Station had received the same but no action has yet been taken.
10. That thereafter, finding no alternative, the complainant had sent a said written complaint to the Commissioner of Police, Siliguri Police Commissionerate via speed post on 04/03/25 having consignment no. RW203694845IN but till date no actions have yet been taken by the concerned police authority and no case has been registered on the basis of the said written complaint.
