I, ATRI SHARMA, son of Late Vaidya Nath Sharma, resident of Bhagwati Apartments, Punjabipara, Siliguri - 734001, would like to inform you as under:

I am holding a post of Secretary in the present District Committee of Darjeeling District Trinamool Congress (Plains). On 5th May 2025, at around 9:28 pm, I received a WhatsApp call from my advocate colleague, Shri Niloy Roy, from his mobile phone number 9474779625. He informed me that a woman named Baby Saha of Pradhannagar was trying to contact me but could not reach my number. He requested that I contact her and sent me her number, 8918635540. I assumed the call had failed due to a network issue. I then called Baby Saha on WhatsApp from my mobile phone at 9:30 pm. Smt. Baby Saha told me that a person named Shibasish Ghosh wished to speak with me, and she handed her phone to him. Mr. Ghosh stated that he is an I-PAC official from Kolkata, associated with our leader Sri Abhishek Banerjee's office, and has supervisory authority over this region. He was there to select potential candidates for president of the Darjeeling District Trinamool Congress (Plains).

He further told me that he had heard good things about me and requested my biodata urgently. They planned to return to Kolkata on May 6, 2025, at 4:30 p.m by flight. They requested a meeting at Hotel Manila in Pradhannagar the next day, between 10:00 and 10:30 am, as they were staying there. They said the cost to secure the presidency of the Darjeeling District Trinamool Congress (Samatal) was Rs. 2,500,000 (Rupees twenty-five lakhs), requiring an initial payment of Rs. 500,000 (Rupees five lakhs) in cash, with the remaining Rs. 2,000,000 (Rupees twenty lakhs) due upon confirmation. He said that after receiving the initial payment, he would provide an acknowledgement/document signed by a high-ranking I-PAC official close to our leader Sri Abhishek Banerjee.

After hearing everything, I told him I was not interested. After my refusal he threatened me of dire consequences. He also told me that he will ruin my reputation. The next day, I became curious and verified with my party leaders and the I-PAC office in Kolkata whether a person named Shibasish Ghosh was associated with them. It was revealed that the said person is not associated with I-PAC or our leader Sri Abhishek Banerjee's office in any capacity.

I then felt that this person tried to deceive me using forged documents. Though I escaped this fraud, someone else might become his victim. So I decided to lodge this complaint and request you to investigate the matter and take appropriate action against this fraudster in accordance with law.
