I, Swajyoti Jha, S/O Somnath Jha, resident of Rajganj, Jalpaiguri, Pin: 735134 would like to inform you that on 05/05/2025 at 03.15 Pm, while I was returning from university a man with a scooty (Board no. WB74BE7418) in front of Hotel Diamond, Mallaguri, interacted with me and offered me to drop to the location from where buses for Jalpaiguri were leaving and thus I also went with him trusting him. But, then I was taken to an unknown lane without my consent, there the man threatened me of life and extorted money from me. First, he took 7000 from my money bag and then forced me to transfer money via gpay to two more shops and the man also took those transferred money in cash. In all total, he extorted ₹ 10,000 from me and then again left me to Mallaguri. ~~₹ 1320 to one shop,~~
