With due respect, I, **SRI AMAN GUPTA**, Son of Santosh Kumar Gupta, resident of Shaktidham Apartment, Near P.C. Mittal Bus Stand, Post Office Sevoke Road, Siliguri, Police Station Bhaktinagar, District Jalpaiguri-734001 (W.B.), beg to lodge this complaint with your good office to the following effects:-

- 1) That I am in physical possession of semi commercial/commercial premises measuring about 4144 Sq.Ft. being No. S-22, S-23, S-24 & S-25 on the second floor of a building namely "The Planet", situated at Sevoke Road, P.O. Sevoke Road, Siliguri, P.S. Bhaktinagar, Dist. Jalpaiguri, in the state of West Bengal.
- 2) That the said premises is occupied by me and the owner of Swidish Bar cum Restaurant and legal proceedings are pending in respect of the said premises as well as said business.
- 3) That on 08.05.2025 at about 5:00 a.m., **Sri Basant Agarwal**, Son of Late Mahabir Prasad Agarwal, **Sri Shyam Kansal**, Son of Late Suraj Bhan Agarwal, **Sri Rabindra Arya**, Son of Late Jawarlal Arya, **Sri Hemant Tibrewal**, Son of Late Shyam Sunder Tibrewal, all are partners of **FOUROFUS REALTY LLP**, a Limited Liability Partnership Concern, having its registered office at SBDEE Sales Corporation, Sugeeta Kunj, Station Feeder Road, Post Office- Siliguri Bazar, Police Station- Siliguri, District- Darjeeling, PIN- 734005, West Bengal and their men and persons about 50-60 persons came to my above noted shop premises, situated at "The Planet", Sevoke Road, P.O. Sevoke Road, Siliguri, P.S. Bhaktinagar, Dist. Jalpaiguri along with weapons and started to assault my security guard physically and started to enter into my said shop premises forcibly by breaking the lock and key with an intention to commit dacoity.

- 4) That in the meantime, my security guard informed me and thereafter, I rushed to my said shop premises and the above named persons and their men and persons attacked me and stopped me outside of my said shop premises and they asked me not to enter into the shop premises and also told that they are the owners of the said shop premises but when I refused to their illegal demand, they assaulted me physically and also threatened me with dire consequences and at the time of leaving, they have also taken away valuable furniture.
- 5) That for the acts of the above named persons, I along with my staffs have been passing our days in very difficulties owing to that all the above named persons are very much criminal in nature.

Under the above circumstances, I would request you to investigate the matter and take all necessary legal action against said Sri Basant Agarwal, Son of Late Mahabir Prasad Agarwal, Sri Shyam Kansal, Son of Late Suraj Bhan Agarwal, Sri Rabindra Arya, Son of Late Jawarlal Arya, Sri Hemant Tibrewal, Son of Late Shyam Sunder Tibrewal, all are partners of FOUROFUS REALTY LLP, a Limited Liability Partnership Concern, having its registered office at SBDEE Sales Corporation, Sugeeta Kunj, Station Feeder Road, Post Office- Siliguri Bazar, Police Station- Siliguri, District- Darjeeling, PIN- 734005, West Bengal, and also take necessary measures for our safety and security for the ends of justice.
