I, Shri. Sumit Kumar Sharma, S/o. Shri. Dilip Sharma, R/o. 204 Anjani Apartment, Ganga Nagar, Anjani Apartment, Block - F, Road No. 2, P.O. Siliguri Bazar, P.S. Siliguri, Dist: Darjeeling, in the State of West Bengal - 734005 the undersign, employee of M/S. NORTH BENGAL STEELS, a legally registered business entity engaged in the trade and distribution of products manufactured by Shyam Steel, having its registered business at 3rd Mile Sevoke Road, Near OSL Service Centre, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar, Dist: Jalpaiguri, West Bengal - 734001, and in my capacity as an authorized legal representative of the said business firm I am constrained to lodge this formal police complaint against MAJHARUL ISLAM, Proprietor of Krishi Bhandar (GST- 19ACNP12746Q1ZT), having his place of business at Ghughujhara, Bidhan Nagar, P.O. & P.S. Bidhan Nagar, Dist. Darjeeling - 734425, for committing the offences of cheating, criminal breach of trust, dishonest misappropriation, and deliberate non-payment of legally owed dues. The circumstances necessitating this complaint has been detailly outlined below:

- That M/S. NORTH BENGAL STEELS, in good faith and in the course of regular business, appointed Majharul Islam as a retailer/channel partner under the authorized dealership of Shyam Steel, commencing from August 2020. The said relationship was governed by trust and commercial confidence, with delivery of goods lifted from the warehouse located at 3rd Mile Sevoke Road, Near OSL Service Centre, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar, Dist: Jalpaiguri, West Bengal - 734001. The business transactions between the firm and the alleged accused were made on CREDIT TERMS extended by the firm over the course of the business relationship, including through Financial Year 2022-2023.
- That as per the ledger maintained and mutually acknowledged, a total sum of Rs.1,90,268/- (Rupees One Lakh Ninety Thousand Two Hundred and Sixty Eight) Only was outstanding as on 01.04.2022 and out of which the alleged accused has made only part payments totaling Rs.60,000/- (Rupees Sixty Thousand) Only {16th August, 2022 (Rs.20,000/-), 29th September, 2022 (Rs.20,000/-) and 27th December 2022 (Rs.20,000/-)}. Despite repeated personal and telephonic requests, the remaining balance of Rs.1,30,268/- (Rupees One Lakh Thirty Thousand Two Hundred and Sixty Eight) Only remains unpaid, and simple interest accrued on the same amounts to Rs.50,804.52/- (Rupees Fifty Thousand Eight Hundred and Four point Fifty Two

Paisa) Only till March 2025, resulting in a total outstanding of Rs.1,81,072.52/- (Rupees One Lakh Eighty-One Thousand Seventy-Two and Fifty-Two Paise only).

- 3. That the alleged accused has willfully defaulted on payments, avoided communications, and shown deliberate intent to evade lawful liability, thereby causing wrongful loss to the firm and unlawful gain to himself, when communicated to the alleged accused through telephonic medium regarding the matter the person started abusing me and the firm with various defamatory and filthy languages and also challenged the capacity of the firm in respect to the recovery of the firm's due amount and also threatened me describing his unlawful sources. This amounts to a clear case of criminal breach of trust, cheating and threatening with criminal intent which also highlights his nature of being a habitual offender.
- 4. That despite issuance of a formal legal notice, vide Reference No AEL/MAR/007/25 dated 26th March 2025 which was received by the alleged accused on 27th March 2025, the alleged accused has failed to respond or comply with the legitimate demands of repayment.
- 5. That irrespective of his actions and intentions, the firm with a positive intent to amicably settle down the legitimate dues standing against him, again on 23rd April, 2025 the firm has issued a Final Reminder Legal Notice vide Notice Reference No AEL/APR/005/25 as sent through India Post vide Consignment Tracking Number RW734553753IN, which the alleged accused person has clearly refused to receive, a copy of the Consignment Tracking Report has been attached below as one of annexures. Such conduct reflects his criminal intent to deceive the firm from the very inception and had misappropriated funds under the guise of a commercial relationship between the firm and himself.

Considering the facts and circumstances as briefed above it is therefore requested before your concerned department to kindly consider the urgency and seriousness of this complaint and register this written complaint as an FIR under appropriate sections against the said alleged accused person namely Majharul Islam and take appropriate legal and coercive steps to ensure recovery of the dues along with penal consequences for the criminal actions.
