Respected Sir,

I, Smt. Gauri Goswami, W/o- Late Jatindra Chandra Goswami, resident of Vill. & P.O. Rangapani, P.S. Bagdogra, Dist. Darjeeling, would like to report you the following facts:-

- 1) That I am widow senior citizen lady age about 67 years. My husband was expired on 26/01/2023 and he was retired service person. After death of my husband I get pension as his legal wife.
- 2) That we have 2 daughters and one son and after death of my husband I living with my only son namely Sri Sumit Chandra Goswami, S/o- Late Jatindra Chandra Goswami at above mention address. Once I faced brain stroke 2 times and also I have several disease i.e. heart disease, pressure etc. and till I had admitted at Hospital for those disease on several time. All the expenses barred by me and by my son-in-law Sri Samir Chakraborty.
- 3) That my only son Sumit Chandra Goswami snatch all my pension by forcefully and acquire all rent of shops amount of Rs. 25,000/-per month which are belongs in our same residential building after death of my husband. Even he never providing me proper food, medicines, expenses of treatment and others livelihood necessary of every senior citizen.
- 4) That on several occasion my son and his wife Smt. Etika Goswami, W/o. Sumit Chandra Goswami always they used filthy languages and intentionally stop water and electricity connection at day and night and threatened me to kill. I always restrained by them to visit with our neighbours or any relatives or my daughter. Even after my daughter Smt. Nanda Chakraborty, W/o. Sri Samir Chakraborty of Subhash Pally, Siliguri when she came to visiting with me or came her matrimonial home, then my son and his wife restrained her to enter at our house and threaten her not to provide any kind of help to me.

- 5) That many time I approached to the local Panchayet and Pradhan to take necessary steps but they did not take necessary action against my son.
- 6) That my son is a habitual drunk person and many times he torture in mentally and physically upon me. I have no option to live peacefully at my home and finally on 12/03/2025 at about 03.00 P.M my son forcefully put out me from my house without any reason. My son told me that I will not be permitted to enter my house for ever. Presently I took shelter at my daughter's house at Siliguri to save my life and I feeling inscure and scared in every moments in my life for those reasons.
- 7) That for all these reasons I have been suffering from mental agony, depressions and illness.

I, therefore request you to kindly take necessary legal action against the aforesaid persons namely Sri Sumit Chandra Goswami, S/o. Late Jatindra Chandra Goswami and his wife Smt. Etika Goswami, W/o. Sumit Chandra Goswami for their commission of the aforesaid offences.
