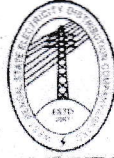

Sub: Intimation regarding Theft of office equipment under Bagdogra CCC, WBSEDCL.

Sir

On 02nd of May 2025, at around 8 A.M. while opening the Kiosk for payment by the consumers, under Bagdogra CCC, it was seen that some miscreants had stolen the outdoor Split AC unit of the Kiosk of WBSEDCL along with 2.5m of copper cable and other additional cables.

The Manufacturer of the AC Outdoor Unit is Voltas, and approximately 2.5m of copper wire is stolen along with additional cables. The location of the payment kiosk is on ground floor of old Lower Bagdogra GP office beside Gurudwara at Biharmore, Bagdogra.

For stable operation of the Kiosk these items are extremely crucial. Without these items the Kiosk would remain non functional causing a terrible loss to the company. Therefore I would like to request you to kindly investigate the matter as some unknown miscreants have stolen these parts from existing structure. This is for your necessary information and necessary intimation.
