It is to inform you that the pedestrian guard rail (median railings) has been installed at many locations of the subject mentioned project but some of the intermediate grills of this pedestrian guard rail have been cut and theft by some miscreants at Hansquan market (Ch. Km 556+100, Ch. Km 556+200, Ch. Km 556+300), Bhujipani (Ch. Km 562+400) and Bhuttabari (Ch. Km 560+300) as noticed during site visit. Photographs are attached for your kind perusal. This is very dangerous for the road users and it may invite road accidents.

Hence, you are requested to look into the matter to minimise this type of incidence in consideration with the safety of the road users.
